Summary of key findings for parents

early years provision

The provision does not meet requirements

- The project coordinator is not familiar with changes to safeguarding legislation. In addition, she lacks a secure understanding of the action to be taken in the event of an allegation being made against a member of staff. Furthermore, her safeguarding policy and procedures do not cover the use of mobile phones and cameras in the scheme.
- The project coordinator understands the importance of developing strong links with other settings and health care professionals to ensure continuity of care and develop a strong ethos of joint working. She has excellent arrangements to support disabled children and those with special educational needs.
- The project coordinator has a sound knowledge of how to provide a range of activities that are linked to children's interests and that complement their learning at school. She understands how this positively supports children to continue to develop their knowledge and skills.
- The project coordinator confidently discusses how she promotes children's understanding of leading healthy lifestyles. She has a clear understanding of how to support children's physical development, by offering them opportunities to explore and play outdoors.
- The project coordinator understands the need ensure a member of staff who holds a current paediatric first-aid certificate is on the premises at all times. The scheme is covered by current public liability insurance.
- The project coordinator understands the need for regular self-evaluation of practice in the scheme, to help identify areas for improvement. She discusses how she ensures that records and documents are shared with parents and approaches she uses to gather their comments.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage and the Childcare Register the provider must:

improve knowledge and understanding of safeguarding policy and procedures, to ensure an up-to-date knowledge of safeguarding issues, specifically the procedure to follow in the event of an allegation being made against a member of staff and the safe use of mobile phones. 07/05/2016

Aireborough Supported Activities Scheme was registered in 1988. The scheme is open each weekday for the first three weeks of the school summer holidays from 10am to 3pm, for three to five days during the Easter holidays from 10am to 3pm and for a Christmas activity day during December from 10am to 3pm. The scheme is run solely for disabled children and for children with moderate to severe special educational needs. At the time of the inspection, there were no children on roll in the early years age range.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
