Summary of key findings for parents

This provision is outstanding

- The childminder has an exceptionally thorough knowledge of how to safeguard children and manage any concerns she may have about their welfare. Thorough risk assessments promote children's safety in her home and on outings.
- The quality of teaching is outstanding. For example, the childminder continues to expand her knowledge and understanding as she undertakes her degree. She is proactive in using her network of outstanding childminders and local training initiatives to promote excellent levels of achievement for the children in her immediate care.
- The childminder's thorough assessments ensure she knows precisely which aspects of children's learning to focus on next. She expertly adapts her teaching and use of resources to help every child achieve outstanding levels of progress.
- Children form exceptionally warm and secure relationships with the childminder and each other. Children's behaviour is generally impeccable. They feel secure and enjoy a superb balance of opportunities for adventure, activity, reflection and rest.
- Partnerships with parents, other providers and professionals are excellent. This has a significant impact on meeting children's care and learning needs, and supports continuity between home and childcare settings.
- Children's moves to new settings and new challenges are smooth. Children know what to expect and are equipped with the skills and confidence to flourish.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

continue to evaluate and refine the arrangements to share information about children's progress with their parents.

Inspection activities

- The inspector observed care routines and teaching, and the impact of these on children's safety, welfare and learning.
- The inspector reviewed policies and discussed the procedures relating to children's safety and welfare with the childminder.
- The inspector looked at children's records, the childminder's planning and evaluation of activities, and information exchanged with parents.
- The inspector took account of the views of parents in written communication.
- The inspector spoke with the childminder about the impact of her training, experience and practice on children's well-being, learning and development.

Inspection findings

Effectiveness of the leadership and management is outstanding

The childminder continues to sustain outstanding levels of practice, enriching children's lives with her dynamic teaching and exceptional care. Safeguarding is effective. The childminder diligently implements regularly updated, well-researched policies and practical procedures to protect children from harm. She is proactive in securing specialist guidance to meet the needs of individual children and swiftly applies advice to ensure children overcome challenges in their speech and physical development. Parents are 'hugely impressed with her professionalism, passion and the warmth and vibrancy of her setting'. They agree that 'she provides an exceptional level of care'.

Quality of teaching, learning and assessment is outstanding

The childminder is an enthusiastic and inspirational teacher who sets extremely high standards for herself. Children have tremendous fun creating and extending stories as they play. They reflect the childminder's wonderful sense of joy, her imaginative role play and her lively observations of finer details in the world around them. The childminder is currently trialling an online system for sharing information with parents, as well updating parents verbally and through various other formats. However, the childminder's accurate self-evaluation identifies that this combination is impractical and needs to be consolidated.

Personal development, behaviour and welfare are outstanding

Children's laughter is infectious as they try to master new physical skills. For example, they sow and harvest herbs, pick vegetables at a local farm, and search the supermarkets for the right number and type of vegetables to add to their home-cooked meals. The childminder puts experiences in place that develop children's confidence in their own abilities and their motivation to explore new things. For example, parents marvel at the bags of resources and experiences she creates for them to help their children gain specific milestones in their health and self-care. For example, the childminder helps children overcome anxieties as they enjoy group visits to a dentist and practise having their feet measured at a shoe shop.

Outcomes for children are outstanding

Children are extremely happy, relaxed and good to each other. They learn to take responsibility for themselves, such as storing their belongings appropriately. Children are enthusiastic and inquisitive learners, who are quick and confident to ask the next question, make links and apply their understanding. Children are exceptionally well prepared for the next stage in their learning and for school. They are self-assured, articulate and sociable, confident to speak with adults, and capable of working as a team and respecting other children's interests.

The childminder registered in 2004. She lives in Hersham, Surrey. The childminder operates her service all year round from 7.30am to 6pm, Monday to Thursday, except for bank holidays and family holidays. The childminder receives funding for the provision of free early education for children aged three and four years. The childminder holds an appropriate childcare qualification at level 3 and is currently near completion of a Foundation Degree.
