Summary of key findings for parents

This provision is inadequate

- The childminder has failed to notify Ofsted about all significant events within the required timescale.
- The childminder does not have a secure understanding of the requirements of the early years foundation stage in relation to the records she needs to keep. She has not maintained a record of children's attendance or obtained all the required parental consent agreements to keep children safe.
- The childminder has not obtained from parents the essential information required to fully support all children's care and learning and promote good outcomes.
- Parents are not given up-to-date information about the policies and procedures and the assistants' roles as key persons.
- The childminder and assistants sometimes overlook opportunities for older children to do things for themselves and develop their independence skills.
- Self-evaluation is not used effectively to identify strengths, weaknesses and priorities for improvement.

It has the following strengths

- Children are happy and confident in the setting and build warm relationships with the childminder and her assistants.
- Children access a broad range of activities linked to all areas of learning. Since the last inspection, the indoor learning environment has been improved to give children more space and access to a wider range of resources.
- Children enjoy regular outings to local community groups where they meet other people, make new friends and learn to respect differences in society.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

provide more opportunities for older children to be able to do things for themselves and develop their independence skills

improve self-evaluation and develop a more accurate overview of the quality of the provision to raise standards in children's care and learning.

Inspection activities

- We carried out this inspection as a result of a risk assessment, following information we received about this provider.
- The inspector observed the quality of teaching during activities indoors and outdoors and assessed the impact this has on children's learning.
- The inspector evaluated a focused singing activity with the childminder and held discussions with the childminder, two assistants and children.
- The inspector viewed a sample of the children's development records.
- The inspector reviewed evidence of the childminder's and assistants' qualifications and suitability, self-evaluation, risk assessment and policies and procedures.
- The inspector took account of the views of parents spoken to on the day and from their responses to surveys organised by the childminder.

Inspection findings

Effectiveness of the leadership and management is inadequate

Arrangements for safeguarding are ineffective. The childminder does not maintain all the required records to promote children's health and safety. She has not kept a record of children's attendance for several months. Procedures for the safe administration of medication are not followed. When children join the setting, insufficient information is obtained about each child's parents and carers. Following a car accident involving one of the assistants, with a minded child as a passenger, the childminder did not notify Ofsted in line with requirements. Although the assistants all hold appropriate car insurance, the childminder has not obtained permission from parents to leave children in the care of an assistant for short periods of time. There is potential for further misunderstandings about care practices as the information given to parents is not always accurate or up to date. The childminder is appropriately qualified. She monitors the suitability of her assistants and ensures they are appropriately deployed. They have all completed relevant safeguarding training to ensure they know how to deal with child protection concerns. They also attend local authority workshops and cluster meetings so they gain new ideas for learning experiences. However, not all the issues identified at the last inspection have successfully been addressed. The childminder does not use self-evaluation effectively to identify the strengths and weaknesses in her practice. Furthermore, she does not ensure that the priorities for improvement are quickly addressed to raise standards in her provision.

Quality of teaching, learning and assessment requires improvement

The childminder and her assistants have a suitable understanding of how young children learn. Each child has a dedicated key person who appropriately observes and assesses their progress and achievements. The childminder then identifies the next steps in learning and tracks all children's development to ensure there are no gaps in learning. This information is regularly shared with parents and they are given ideas to continue their child's learning at home. However, teaching requires improvement as insufficient information is obtained from parents about every child's capabilities, interests and enthusiasms when they join the setting. This means the key persons are not able to plan challenging activities securely tailored to children's learning needs from the outset. Nevertheless, children can access an interesting blend of adult-led tasks and activities they select for themselves. The interaction between children and adults is lively and friendly. Children are encouraged to develop their language skills as they talk about storybooks and sing their favourite songs and rhymes with gusto. Parents say they are satisfied with the care and education their children receive.

Personal development, behaviour and welfare are inadequate

Systems for administering medication are not good enough and this puts children's health and welfare at risk. Children's behaviour is managed appropriately. They have regular opportunities to go outside and be physically active in the fresh air. They confidently ride wheeled toys and learn to climb safely on apparatus. The childminder and assistants make sure children are closely supervised. They encourage children to follow good hygiene routines and support them to make healthy choices about the food they eat.

Outcomes for children require improvement

Overall, children, including those who receive funding, make steady progress. They begin to understand simple rules, resolve their differences amicably and respect the views of others. Children enjoy learning new things and are developing some of the skills they will need for starting school. However, the childminder and her assistants are not making the most of opportunities to challenge older children and encourage them to do things for themselves.
