# Summary of key findings for parents

### This provision is outstanding

- Extremely skilled staff have high expectations of all children. They plan challenging activities which support and complement children's learning exceptionally well.
- The manager gathers in-depth information from parents and school staff about children's care needs and stage of development. This helps her to tailor care and activities to the individual needs of children from the outset.
- Staff know children extremely well and are quick to respond to their individual needs. This helps support children's emotional well-being exceptionally well and helps them form secure attachments.
- Staff provide a vast range of high-quality educational resources for children to choose from. Children move around the setting with confidence. They are extremely independent and capable leaders of their own learning.
- The manager places a strong emphasis on children's safety. She has an excellent understanding of the process for reporting concerns about children's welfare and works in close partnership with the school's designated safeguarding officer.
- The manager is passionate and in pursuit of excellence in all areas of her provision. She is an outstanding role model for staff, who share her enthusiasm and are highly committed to continuous development.

# What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

explore further ways to share the exceptional planning and resourcing of activities with other providers that children attend.

## **Inspection activities**

- The inspector observed the quality of interactions indoors and outdoors, and assessed the impact this has on children's learning.
- The inspector completed a joint observation with the manager.
- The inspector held a meeting with the setting manager and her line manager. She looked at relevant documentation, such as records of attendance and evidence of the suitability of staff working in the setting.
- The inspector read feedback from parents during the inspection and took account of their views.

# **Inspection findings**

#### Effectiveness of the leadership and management is outstanding

A new manager was appointed in 2014. She has evaluated the effectiveness of the provision, taking into account the views of parents and children, and has successfully implemented positive changes. The quality of planning and the resourcing of activities are outstanding and worth sharing with other settings that children attend. The manager has begun to invite other providers to view the setting and is keen to continue sharing her excellent practice. The arrangements for safeguarding are effective. The manager works closely with the school staff, to ensure that any concerns about children are shared and closely monitored. Staff are vigilant and maintain accurate records of children's attendance at all times. Staff have undertaken high-quality training, delivered by the manager and are committed to furthering their professional qualifications. The staff's outstanding practice helps children to embed the skills they are learning in Reception class. This prepares children exceptionally well for the next stage in their learning. Parents are highly complimentary about the quality of the activities and the level of care provided.

#### Quality of teaching, learning and assessment is outstanding

The manager and staff team have created a highly stimulating environment for children which supports children's learning exceptionally well. Staff use every opportunity to develop children's communication and language. For example, they are extremely skilful in their interactions with children during role play, modelling language and asking questions to extend children's thinking. Children are developing excellent mathematical skills. For example, they take part in skipping competitions and are supported by staff to count and record the number of jumps completed by each child. They work out who has jumped more, who has jumped less and who is the winner. Staff make observations of children during play and plan for children's individual next steps. Next steps are implemented into weekly plans alongside children's own ideas for activities. Staff work in close partnerships with parents and staff at school and share information about children's learning. This provides a high level of continuity across all settings that children attend.

#### Personal development, behaviour and welfare are outstanding

Children have an extremely positive relationship with all staff. Staff know children exceptionally well and possess an in-depth understanding of children's individual needs. This supports children's emotional well-being very well. Staff encourage children to work out solutions to their own problems, and behave in a kind and courteous manner towards each other. Children are very confident and are developing excellent social skills. There is a wide variety of excellent resources which helps children develop their understanding of the world and diversity. Staff place a strong focus on teaching children about healthy lifestyles. For example, children help staff place orders for fruit each week, making choices from a large selection of fruit images on display. Children enjoy many opportunities to develop their physical skills in the outdoor area and the nearby woodland area.

Westerton Out of School Club was registered in 2008 and is one of a number of schemes run by 4Children. The setting operates from 7.30am to 9am and 3.10pm to 6pm, Monday to Friday, term time only. It also offers places during school holidays from 7.30am to 6pm. The setting employs four staff of whom all hold an appropriate qualification at level 2 and 3.
