Summary of key findings for parents

The provision meets requirements

- The childminder has a good understanding of how children learn and develop. She understands how to monitor and track children's progress in a good way. She has good knowledge of how to plan to meet children's individual needs.
- The childminder demonstrates a good understanding of how children learn. She has a wide range of toys and well organised play spaces to help promote all learning areas.
- The childminder has a good understanding of how to safeguard children. She has an up-to-date knowledge of her responsibilities to identify and report concerns for children's welfare. She has effective policies and procedures in place, and knows how to assess her environment for potential risks so children can play in safety.
- The childminder understands how working closely with parents and other early years professionals supports continuity to children's learning and development.
- The childminder is aware of how to evaluate her practice and continues her own professional development. For example, she keeps up to date with new ideas and attends regular training.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2013. She lives in Erith, in Kent. The childminder cares for children Monday to Friday, from 9am to 5pm, all year round. There were no children on roll in the early years age range at the time of inspection. The childminder holds a level 3 early years qualification.
