Summary of key findings for parents

The provision meets requirements

- The childminder is knowledgeable about her responsibilities to safeguard children. She has detailed procedures to follow should she be concerned about a child's welfare.
- The childminder values partnerships with parents and other professionals involved in children's care, to help provide consistency in children's experiences and learning.
- The childminder understands the learning and development requirements. She values the importance of using observations and assessments to reflect on children's development and monitor their progress. She knows how to plan for children's unique needs, so all children make the best possible progress, in preparation for school.
- The childminder is enthusiastic and evaluates the quality of her setting. For example, she attends relevant training to gain an understanding of recent changes, and keep her own knowledge and skills up to date.
- The childminder understands how to support children's good health and well-being. She knows how to be a positive role model, including promoting children's positive behaviour towards one another.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the childminder about her practices and procedures, including how she intends to deliver the educational programmes for children.
- The inspector viewed the areas of the premises that are available for childminding and discussed safety arrangements.
- The inspector sampled required documentations and records that the childminder plans to use to support children's welfare and learning.
- The inspector held discussions the childminder about her systems for self-evaluation.
