Summary of key findings for parents

The provision meets requirements

- The childminder has a variety of appropriate resources for children. She understands how to plan activities to support children's needs and how to prepare them for school.
- The premises and garden are safe, secure, clean and fit for purpose. The childminder undertakes appropriate risk assessments to help minimise hazards.
- The childminder knows how to build strong links with other providers and how to share information between other professionals and parents. She regularly reviews her provision and is highly committed to continuing professional development.
- The childminder knows how to help children to form secure relationships and develop their self-esteem. She also understands how to positively manage children's behaviour.
- The experienced childminder has excellent knowledge of child protection and understands her responsibility to protect the welfare of children in her care. She attends regular training to keep up to date with developments in procedures.
- The childminder recognises the importance of providing children with a choice of healthy meals and snacks, as well as a range of opportunities for fresh air and exercise.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector looked at policies, procedures and documents the childminder will use when caring for children.
- The inspector discussed with the childminder how she intends to support children's play and learning.
- The inspector discussed with the childminder how she monitors her provision and develops partnerships with parents and other professionals.
- The inspector discussed with the childminder how she delivers the educational programmes for children and undertakes observation, assessment and planning.

The childminder registered in 2004. She lives in Greenwich, London and provides care all year round between 7.45am and 6.30pm. At the time of the inspection there were no children present.
