The provision meets requirements

- The childminder understands how to monitor children's progress from their starting points. She knows how to plan a range of interesting and exciting activities that support children's individual learning needs.
- The childminder recognises the importance of working with parents and other settings that children attend. She is aware that sharing information encourages consistent and complimentary teaching to ensure children make good progress in their learning.
- The childminder knows how to promote good values, such as how to behave. She understands how to help children share their thoughts and views, and appreciate other people's differences and similarities.
- The childminder is aware of safeguarding issues. She knows the importance of sharing information with relevant professionals to keep children safe.
- The childminder understands the importance of collecting the views of parents and others to help her self-evaluate and identify areas for improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2013 and lives in Upper Edmonton, North London. She operates each weekday, all year round. There were no children in the early years age range on roll at the time of the inspection. The childminder holds a level 3 childcare qualification.
