## Summary of key findings for parents

#### The provision meets requirements

- The childminder is aware of her responsibility to ensure adults working with her and the children are suitable. She demonstrates a good understanding of how to keep children safe and teach them to be aware of hazards.
- The childminder has clear procedures she will follow if she has any safeguarding concerns about children's welfare to help her protect and safeguard children.
- The childminder clearly explains her knowledge of the learning and development requirements. She understands how to plan and organise activities for all children. She will involve parents and carers to ensure children make the best possible progress.
- The childminder describes clear strategies to use to engage children's positive behaviour and encourage them to be polite and think about others.
- The childminder discusses how she will provide children with healthy food choices and encourage their active physical play.
- The childminder demonstrates a strong commitment to improve her service. For example, she takes regular training and shows how she seeks the views of parents.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector had a tour of the areas of the home used for childminding.
- The inspector had discussions with the childminder relating to her knowledge and understanding of the requirements for safeguarding, welfare and development.
- The inspector sampled relevant documentation, including policies and procedures, insurance and documentation used to support children's welfare.
- The inspector checked evidence of suitability of the childminder and her assistant.
- The inspection took account of the views of parents and carers of older children attending the setting.
