## Summary of key findings for parents

## This provision requires improvement. It is not yet good because:

- The childminder does not provide children with a suitable environment and equipment to maintain their safety during overnight care. This is also a breach of the Childcare Register requirements.
- The childminder does not always help children recognise differences and similarities in their own backgrounds and other cultures.
- Children do not always have the best possible opportunities to develop their early writing skills.

## It has the following strengths

- The childminder makes good observations and assessments of children's development and identifies children's next steps in learning effectively. She plans appropriately challenging activities, which help all children make good progress from their starting points.
- The childminder has a positive attitude to self-evaluation and makes strong use of parents' views to help her move her practice forward.
- The childminder is clear about her role in safeguarding children's welfare. She is aware of the action to take and who to contact should she have any concerns.
- The childminder extends children's communication and language development effectively. For example, she introduces new vocabulary and reinforces words with actions.

## What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage and the Childcare Register the provider must:

#### To further improve the quality of the early years provision the provider should:

- strengthen further children's awareness of people's similarities and differences in their family backgrounds and other cultures
- increase opportunities that older children have to practise their early writing skills.

#### **Inspection activities**

- The inspector discussed risk assessments with the childminder and inspected all areas of the premises, including those for overnight care.
- The inspector sampled a range of documents including children's assessment folders, planning, children's next steps, and some policies and procedures relevant to the inspection.
- The inspector observed the daily routines and practice, and discussed the organisation and management of the childminding service with the childminder.
- The inspector read letters of reference from parents, to take account of their views.
- The inspector carried out a joint observation with the childminder.

# **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

Safeguarding is effective. The childminder is aware of any signs that may cause concerns about a child's welfare. She has a positive attitude to her professional development to improve outcomes for children. For example, she completes online training and seeks support from other professionals. The childminder has strong links with other settings that children attend to ensure they have continuity of care and learning. She has completed written risk assessments and is constantly vigilant while children are playing to ensure she minimises any hazards. For instance, she makes use of stair gates to stop children accessing the kitchen. However, the equipment and facilities used to provide overnight care are not sufficiently safe and secure. For example, corridors are not clear of furniture and other items, and overnight sleeping arrangements are not appropriate for young children. The childminder keeps parents informed about their children's care. For example, she shares information about activities and experiences that children take part in, through communication books and regular discussions.

## Quality of teaching, learning and assessment is good

The childminder's quality of teaching is good. For example, the childminder makes effective use of neighbouring environments to enable children to learn about the natural world and the local community they live in. She has a strong focus on literacy, to support children as they learn about letters and sounds. For instance, they read a story looking at the letter 'B' before searching for objects in the room beginning with 'B'. The childminder makes good use of skilful questions to introduce mathematical language into children's play. For instance, children accurately count the balls they throw into the box.

## Personal development, behaviour and welfare require improvement

The childminder builds secure and supportive relationships with children in her care. She promotes each child's self-esteem and helps them to gain increasing confidence and independence. Children learn about the importance of exercise and a healthy diet. For instance, she encourages them to eat their vegetables and extend their learning through discussion about how vegetables grow. The childminder promotes children's personal and social skills well. For example, they enjoy sharing a range of tools to investigate sand and water. Children learn to behave well. However, they have few learning experiences that help them to value people's differences and similarities. Children do not always have ready access to resources that encourage them to practise their early writing skills as they play.

#### **Outcomes for children are good**

Children make good progress in their learning and development. They are confident, sociable and eager to join in activities with friends. Children develop the skills needed for their future learning and are prepared for the move to school.
