The provision meets requirements

- The childminder has a good understanding of how children learn. She knows how to plan a range of activities to promote children's learning, and has a suitable range of toys and resources in her setting.
- The childminder understands how to keep her home safe and secure and takes action to minimise hazards to children. The childminder knows what action she would take if she had any welfare concerns about a child.
- The childminder knows how to promote children's physical health; for example, by providing healthy foods and daily opportunities for physical exercise.
- The childminder understands how to use her observations and assessments of children's learning to plan for their future learning and monitor their progress.
- The childminder knows how to work in partnership with parents to share information about children's progress.
- The childminder understands how to keep her, and her assistant's, skills and knowledge up to date, and the value of training to improve her practice further.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
