The provision meets requirements

- The childminder understands how to promote children's safety and protect them from harm. She is able to recognise and report any possible signs and symptoms that may raise cause for concern.
- The childminder understands the learning needs of children. She knows how to plan the environment to help children develop key skills for their future learning. She knows how to use assessments to identify children's starting points and monitors their progress.
- The childminder knows how to evaluate and reflect on her practice. She gathers parents' views and follows advice from the local authority. She keeps her knowledge of childcare up to date, such as through regular training.
- The childminder values working in partnership with parents and others professionals to share information and to promote consistency in children's care and learning.
- The childminder is aware of the importance of promoting healthy lifestyles. She provides regular opportunities for children to engage in physical activities and she knows what constitutes a healthy diet.
- The childminder has appropriate strategies for managing children's behaviour and supporting them to develop an awareness of, and learn to value and respect others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector observed the areas in the home used for childminding.
- The inspector engaged in discussions with the childminder about her practice and understanding of the requirements.
- The inspector looked at a sample of the childminder's documentation, including suitability records for herself and the other people living in the home, and children's records.

The childminder registered in 2013. She lives with Stoke Newington, in the London Borough of Hackney. The childminder operates Monday to Friday, from 9am to 6pm, throughout most of the year. There were no children present during the inspection.
