# Summary of key findings for parents

### The provision does not meet requirements

- The provider has failed to ensure the manager's safeguarding knowledge is up to date and she is fully familiar with the club's policies and procedures. The manager is not aware of the correct procedure to follow in the event of an allegation being made against a member of staff.
- Staff show an appropriate awareness of how to plan and provide a range of interesting activities to keep children occupied and engaged, indoors and outside. There is a variety of suitable resources and equipment available.
- Staff demonstrate how they promote children's safety and welfare. For example, they ensure that risk assessments of the premises are undertaken, the emergency evacuation procedure is practised and public liability insurance is maintained. All parts of the premises that are intended to be used for childcare are safe, secure and suitable for their purpose.
- Staff demonstrate an appropriate awareness of how to help children understand behavioural expectations within the club. They know how to provide activities that promote children's independence within their personal care routines and a healthy lifestyle.
- The manager demonstrates her understanding of the importance of gathering information from parents and teachers, in order to support and complement children's individual needs.
- The provider, manager and staff have worked hard to address the previous actions and recommendations. They understand the importance and value the views of staff, children and parents in their self-evaluation process.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

### What the setting needs to do to improve further
