### Summary of key findings for parents

#### This provision is inadequate

- The childminder has a poor understanding of safeguarding matters. She lacks awareness of possible signs that a child may be at risk of harm and does not know what to do in the event of any concerns. This compromises children's welfare and is also a breach of the Childcare Register requirements.
- The childminder compromises children's well-being. She fails to minimise the risk of cross-infection. Children do not learn good hygiene practice and the childminder fails to provide children with daily outdoor play opportunities.
- The childminder does not work with parents or other settings children attend to ensure they receive adequate support to promote their learning and development effectively.
- The childminder lacks commitment to improve outcomes for children and does not meet their individual needs. She has not met the actions raised at the last inspection.
- The quality of children's play and learning experiences are poor and any progress children make cannot be attributed to the childminder's practice. The childminder does not assess how well children progress in their learning. She fails to give adequate support to enable children to gain the skills they need for their future learning.
- The childminder has failed to notify Ofsted of changes that may affect her suitability to care for children, and also changes to household members, as required.

## What the setting needs to do to improve further

The provision is inadequate and Ofsted intends to take enforcement action We will issue a Welfare Requirements Notice requiring the provider to:

## **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The childminder cannot identify signs that may suggest children are at risk of harm and does not know who to contact if she has concerns. She has not taken action in response to weaknesses highlighted at her last inspection and the quality of her provision has deteriorated. The childminder has no understanding of the learning and development requirements and does not monitor children's progress to identify gaps in their learning. She does not work in partnership with parents or other settings children attend. The childminder does not find ways to complement the experiences children have elsewhere, to support their care and learning consistently. She has not informed Ofsted of changes to her circumstances, as required.

#### Quality of teaching, learning and assessment is inadequate

The childminder does not understand her responsibility to assess and promote children's learning and development. She is unaware of children's current needs or where they are in their learning. She does not plan enjoyable play experiences based on their interests, to help them progress. Children are left to occupy themselves with the resources available to them while the childminder uses her mobile phone, watches them play or prepares meals. The childminder's interactions with children are poor, often only consisting of one-word responses to children's questions. This has a detrimental impact on children's language and all-round development, and does not motivate them to learn.

#### Personal development, behaviour and welfare are inadequate

The childminder fails to promote children's well-being adequately. Children's health is compromised. During the inspection, the childminder fed children from one jar of food, using the same spoon. This practice fails to minimise the risk of cross-infection. The childminder does not teach children about the importance of handwashing and exercise. The childminder does not encourage older children to develop their social skills in readiness for school. For example, they children wander around aimlessly while eating. The childminder does not encourage children's independence. They cannot see or select toys easily. The childminder does not ensure children have the opportunity to play outdoors daily, as required.

#### **Outcomes for children are inadequate**

Children do not make adequate progress in their learning and development, including those learning English as an additional language. The lack of purposeful play opportunities inhibits children's enjoyment and learning. They do not gain the skills they need to prepare them adequately for their future learning and school.
