Summary of key findings for parents

The provision meets requirements

- The childminder understands how children learn. She knows how to observe, assess and plan challenging activities to help motivate children across all areas of learning.
- The childminder recognises the importance of working with parents, other providers and professionals to promote good outcomes for children.
- The childminder understands the safeguarding and welfare requirements. She has good knowledge of child protection procedures to follow if she has concerns for a child's welfare. The childminder keeps her knowledge of current legislation up to date.
- The childminder knows how to promote children's well-being and their understanding of living healthy lifestyles. She also understands how to positively manage children's behaviour and to help them to develop independence and self-esteem.
- The childminder understands the need to evaluate her provision, gain parents and children's views and seek further professional development to help maintain good standards.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder registered in 2012. She lives in Slough, Berkshire. There were no children on roll at the time of the inspection. The childminder works from 7.30am to 6pm Monday to Friday, for most of the year. The childminder has a degree in early years education.
