Summary of key findings for parents

The provision meets requirements

- Improvements have been made since the last inspection. The manager and staff have a sound knowledge of child protection procedures. They have completed safeguarding training and know the procedure to follow if they have concerns about a child. Staff demonstrate a good understanding of how to effectively risk assess the environment and minimise any risks to children.
- Staff demonstrate a good understanding of how to help children develop the skills they need to successfully progress through school. They have a strong knowledge of the sorts of activities and experiences that encourage children to communicate and develop independence. Staff understand the importance of following children's interests and ideas to engage and motivate them.
- The centre manager and club manager understand their responsibilities to provide new staff with a purposeful induction, supervise and monitor the work of all staff and identify any training needs. Improvements have been made and implemented.
- Staff have a good knowledge of how to promote children's health by providing nutritious food and daily opportunities for outdoor play. They demonstrate a good awareness of helping children understand how to behave and how to be considerate to one another.
- The manager understands how to work in partnership with parents and schools to meet children's individual care and learning needs. She demonstrates how she seeks the views of parents, children and staff to evaluate the club and drive forward ongoing improvements.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed all areas of the setting and the range of toys, equipment and resources available for children in the early years age group.
- The inspector held discussions with the centre manager, club manager and staff regarding their knowledge and understanding of the requirements of the early years foundation stage.
- The inspector looked at and discussed a range of records, policies and procedures with the manager.
- The inspector checked evidence of suitability and qualifications of staff working with children, and discussed the provider's self-evaluation.

Red Roof Kids Club / Clegwell C.A. was registered in 2012. The club employs three members of childcare staff, all of whom hold appropriate early years qualifications at level 3. The club opens from 3.15pm to 6pm Monday to Friday, during term time only.
