Summary of key findings for parents

The provision meets requirements

- The childminder understands how to safeguard children. She is confident in her knowledge of the signs that may cause concern about children's welfare and how to act if necessary. She follows risk assessments to ensure children's safety.
- The childminder understands how young children learn and can plan for their individual developmental needs. She is familiar with assessment procedures and knows how to use these to identify ways to move children on from their starting points.
- The childminder knows how to work in partnership with parents, and staff in other settings that children attend, to ensure continuity in children's care and learning.
- The childminder identifies the importance of teaching children how to make healthy choices. For example, she has systems in place to teach children about healthy foods.
- The childminder understands how to include everyone in her provision. She follows strategies to teach children to tolerate and celebrate differences between one another.
- The childminder evaluates her practice, taking into account the views of children and parents. She acts on their feedback to improve her service.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
