## Summary of key findings for parents

## This provision is outstanding

- Teaching is of the highest quality. Staff are highly responsive to children's learning and development needs. They make accurate observations and keep detailed records of children's progress.
- The curriculum is enriched by outings and visitors to the setting. Children's creativity is very well promoted. Children benefit from a weekly theatre activity session, where they participate in dance and drama activities based upon storybooks.
- Children's independence and sense of responsibility is nurtured exceptionally well. They have an excellent understanding of the daily routines and benefit from opportunities to serve themselves at mealtimes. Children relish their responsibilities for the day, such as feeding the pet rabbit or helping staff lay the tables for mealtimes.
- Children form exceptionally caring bonds with the staff. This helps them to feel safe and to develop a strong sense of belonging within the group. Children have high levels of confidence in social situations, happily sharing their experiences with staff and visitors.
- Partnerships with parents are exemplary. There is excellent communication and sharing of information about children's care and achievements. Parents are actively involved in their children's learning at every level.
- The provider and her staff have extremely high expectations and continually strive for excellence. Self-evaluation is rigorous and leads to precisely targeted, ongoing improvements.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

evaluate the impact that the proposed deeper analysis of the progress of different groups of children has on raising their achievements to an even higher level.

- The inspector observed a range of activities across all areas of the setting.
- The inspector held a meeting with the provider and conducted a joint observation.
- The inspector spoke to staff and children during appropriate times during the inspection.

## **Inspection findings**

## Effectiveness of the leadership and management is outstanding

The arrangements for safeguarding are effective. Children's safety is of paramount importance. Recruitment and ongoing suitability procedures are rigorous. Utmost priority is given to children's well-being. The provider has implemented thorough systems for supervision. Staff have opportunities to observe each other to share expertise. All staff are highly committed to their work. They actively complete training to extend their teaching skills and enhance children's excellent learning experiences even further. Precise tracking of children's progress means that gaps are quickly identified and strategies put in place to narrow these. The manager has identified the potential to further analyse the achievement of different groups of learners to drive standards even higher. Parents are extremely positive about the high quality of learning and care provided.

## Quality of teaching, learning and assessment is outstanding

Highly qualified staff have a comprehensive understanding of how children learn and have high expectations for all children. They know each child and their families very well. Staff provide exceptionally well-targeted learning opportunities which motivate children and sustain their interest in learning. Children become fully immersed in their activities. Staff encourage babies to investigate exciting sensory objects in treasure baskets. Babies are further captivated, as they explore filling containers and making marks with different objects in the sand pit. Older children write their names. They link letters to sounds and join them together to spell out words. Staff are highly skilled in tailoring activities according to each child's age and stage of development. For example, during a maths activity staff challenge most-able children to count and recognise numbers beyond 20 and effectively support less confident children to use smaller numbers to count in sequence.

#### Personal development, behaviour and welfare are outstanding

Children thrive during their time in the setting. Their behaviour is exemplary. Staff nurture children's emotional well-being exceptionally well, treating all children as unique individuals. Children are very happy and settled, and babies contentedly snuggle up to staff as they begin to settle to sleep. Children follow excellent hygiene procedures and learn how to keep themselves safe. They are provided with an extensive range of healthy meals and have daily opportunities to play outdoors in the imaginatively resourced and well-organised outdoor area. Children learn to value, respect and celebrate differences, such as, other customs and cultures, languages and the individual needs of their friends.

## Outcomes for children are outstanding

Staff help children to become confident and resourceful learners who make outstanding progress in relation to their starting points. Older children are extremely well prepared for school. They learn to form letters correctly and write independently for a wide range of reasons. Children make active choices in their learning and vote on further activities they would like. For example, when they chose to have a baby clinic as their role play area. This promotes children's understanding of democracy extremely effectively. Children are developing good social skills and are encouraged to solve their own problems.

Sarah's Little Angels was registered in 2010 and is situated in Hazel Grove, Stockport. It is open each weekday from 8am until 5.30pm during term time only. The provider works with three members of staff. All staff, including the provider, have early years qualifications at Level 3 and above. The setting provides funded early education for two-, three- and four-year-old children.
