Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder does not use information from her observations of children's learning effectively to plan challenging activities that meet their individual learning needs. Children's progress is not as good as it could be.
- Children do not have many opportunities to develop their early writing skills during their play.
- The childminder does not have an effective system for sharing information with parents so that they can work together to support children's learning in the setting and at home.

It has the following strengths

- The childminder promotes children's early language and communication skills well.
- The childminder knows children well, ensuring she meets their individual health needs and promotes their independence at an early age.
- The childminder demonstrates a commitment to improve her provision. She is working towards a qualification to help her improve the quality of teaching and outcomes for all children.
- The childminder and her assistant are caring and attentive, providing children with regular praise and encouragement as they play. Children behave well and are confident with positive self-esteem.

Inspection findings

Effectiveness of the leadership and management requires improvement

Safeguarding is effective. The childminder knows how to keep children safe and what to do if she has concerns about children's welfare. She has developed partnerships with other professionals for support and training to improve her provision. The childminder monitors the work of her assistant and provides her with ongoing support. This includes ensuring she has a suitable understanding of her role and responsibilities. The childminder has established suitable partnerships with parents and actively seeks their views on how to improve her practice. However, she does not always work with them closely enough so that they know how to support children's learning in the setting or at home.

Quality of teaching, learning and assessment requires improvement

Children confidently explore and enjoy their interactions with the childminder and her assistant. They encourage children to think for themselves. For example, the childminder and her assistant used questions to help children to identify animals when listening to the sounds that they make. They also encouraged children to use their emerging language to copy the sounds they hear. The childminder and her assistant support children's developing self-esteem. For example, they praise them for making good attempts at tasks and completing them. The childminder carries out some observations and assessments of children's progress. However, she does not use the information well enough to identify gaps in children's learning or to plan for their future learning. Consequently, activities do not always have the focus and challenge needed to ensure children make consistently good progress.

Personal development, behaviour and welfare are good

Children are happy and settled. They enjoy listening to stories and singing action songs. The childminder makes sure that children can see the pictures and follow the actions so they are all included in the activities. She encourages their physical skills well, for example, as they join in with the actions, and younger children develop their walking skills and become more mobile. Children behave well. They learn about taking turns and sharing the toys that they are playing with. The childminder promotes children's independence successfully at an early age through good routines. These include encouraging younger children with dressing and using cutlery to feed themselves. The childminder promotes children's emotional and physical well-being effectively.

Outcomes for children require improvement

Children develop social skills, learn to take turns and are confident to participate in new activities. They are eager to sing songs, which helps promote their language development and vocabulary. However, children do not achieve as well with their early writing skills, for example. They make some progress, achieving the basic skills needed to support the move to school.
