# Summary of key findings for parents

## This provision is good

- The childminder engages skilfully with the children to help them enjoy and achieve in their learning. Children take part in well planned and exciting activities which build on their interests and meet their individual needs.
- The childminder knows children well and continually assesses, monitors and supports their learning and development. Children make good progress in their learning. The childminder supports them to gain key skills they need to be ready for the move to nursery or school.
- Children are happy in their surroundings and show pleasure in their play and interactions with the childminder. They demonstrate that they feel safe and emotionally secure in the friendly environment.
- The childminder keeps parents well informed and involves them in their children's learning effectively. For example, she regularly shares information, photographs and development summaries and keeps parents up to date with their children's next steps in learning.
- The childminder has established positive partnerships with professionals and other settings that children attend. For example, she shares information with them that helps to promote consistency in children's learning.

## It is not yet outstanding because:

- The childminder has not focused her professional development sufficiently on raising the quality of her teaching, in order to help children exceed the good progress they already make.
- Self-evaluation does not set precise and challenging targets to raise the quality of the provision to an outstanding level.

# What the setting needs to do to improve further

## To further improve the quality of the early years provision the provider should:

- focus professional development more sharply on raising the good standard of teaching further
- set more challenging targets for improvement and increase the potential of achieving excellent outcomes for all children.

#### **Inspection activities**

- The inspector observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector was given a tour of the areas of the home used for childminding purposes.
- The inspector looked at relevant documentation, such as the self-evaluation and evidence of the suitability of the childminder and other adults in the household.
- The inspector looked at children's assessment records, risk assessments and a sample of policies.
- The inspector spoke with the childminder and children at appropriate times during the inspection.
- The inspector took account of the views of parents and carers from information included in the childminder's own parent survey.

# **Inspection findings**

## Effectiveness of the leadership and management is good

The arrangements for safeguarding are effective. The childminder has a good knowledge of child protection. She understands her responsibility to promote children's safety and knows the procedure to follow if she has a concern about a child's welfare. The wide range of policies and procedures is reviewed regularly to help the childminder maintain her good practice. The childminder successfully minimises potential hazards in her home and implements secure procedures to keep children protected on outings. The childminder gives parents good information about her provision and children's development. She helps to support them in carrying on children's learning at home.

## Quality of teaching, learning and assessment is good

The childminder has a good understanding of how children learn. She plans activities that are interesting to them. Children enjoy investigating insects. They learn early mathematical skills as they count the wings and legs of creatures and discuss the life cycles of butterflies. The childminder models language skilfully. Young children learn different describing words to explain how jelly sounds when they drop it onto the tray from a distance. Children develop their physical skills while playing in the garden. They enjoy competing with each other on an assault course, which the childminder makes for them in the garden. They learn skills, such jumping and bouncing, safely. Children have fun joining in with familiar songs and rhymes, smiling and clapping happily as they do so.

# Personal development, behaviour and welfare are good

Children are happy, confident and motivated learners who thrive in the stimulating environment. The childminder uses visits to groups in the local community to develop their social skills and confidence. Children's behaviour is good. They play cooperatively and are kind and courteous to each other and the childminder who praises them appropriately throughout the day. Children are very independent. The childminder gives children choices about what they want to play with. She reminds them to be considerate of each other and to share toys and resources. Children's safety is given priority. The childminder provides children with hats which help to protect them from the sun when they go out to play. Children benefit from selecting their own healthy snacks. They enjoy picnics in the garden while having conversations about how creatures survive in the water. They use knives to cut their own fruit and know that it is safer to cut grapes in half before they eat them.

# **Outcomes for children are good**

Children are very well prepared for the next stage in their learning and their eventual move on to school. They have positive attitudes towards learning and make good progress in their development. Children learn skills which help them to be independent. They wash their hands and put their own shoes on. Older children are able to write their names using their fingers and paint. They confidently blend the sounds that letters make, demonstrating their good early reading skills.
