## Summary of key findings for parents

#### The provision meets requirements

- The childminder understands how children learn and develop. She has past experience of using observations and assessments of children's progress to help her plan activities. She recognises the importance of ensuring that activities build on what children already know, to extend their skills for future learning.
- The childminder understands her roles and responsibilities in keeping children safe. She knows what action to take if she has any concerns about a child's welfare.
- The childminder knows how to work in partnership with other settings that children attend to share information and provide continuity in their learning and development.
- The childminder knows how to support children's emotional and physical well-being. She recognises the importance of working well in partnership with parents to meet children's individual needs.
- The childminder understands the importance of evaluating her practice and keeping her knowledge and skills up to date. She attends training to support her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector viewed the areas of the home that children use.
- The inspector spoke to the childminder and asked her relevant questions on her understanding of her roles and responsibilities.
- The inspector checked relevant documentation, including suitability checks and the childminder's first-aid certificate.
