## Summary of key findings for parents

#### This provision is inadequate

- The childminder does not know how to safeguard children or share safeguarding procedures with parents. She did not notify Ofsted of a significant event, or that her daughter is acting as an assistant. She does not have a current paediatric first aid qualification or ensure the learning environment is safe for children. These are breaches of the Childcare Register.
- There are no evacuation procedures should an emergency arise.
- Children do not have daily outdoor activities to promote their well-being.
- The childminder has not made the required improvements since the last inspection. For example, she has failed to obtain public liability insurance and has made little progress in improving her knowledge of the early years foundation requirements, including the requirement for the progress check for children aged between two and three.
- The quality of teaching is weak. The childminder fails to promote children's communication skills well enough, monitor their progress, or plan challenging activities. Children do not learn the skills they need for the next stage of their learning.
- Partnership with parents is weak. The childminder does not share information with parents about their children's development to help her plan for the next steps in their learning. She fails to provide them with details about Ofsted if they wish to complain.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

Safeguarding is ineffective. The childminder does not recognise potential signs that a child is at risk, or know who to contact if she has a concern about a child's welfare. She is unclear about the risks relating to the use of mobile phones, or what to do in the event of an allegation. These weaknesses compromise children's safety. The childminder does not hold a current paediatric first aid qualification. She has failed to meet actions from the last inspection. For example, she has not obtained public liability insurance. She does not provide parents with information about how to complain. The childminder's risk assessments are ineffective. For example, glassware is in easy reach of young children, which puts them at risk. Her daughter assists with children's care, but the childminder has not informed Ofsted that she sometimes acts as an assistant. At the last inspection, the childminder was required to improve her understanding of the learning and development requirements, including the requirement for the progress check for children aged between two and three. However, she still does not monitor children's progress or use information from observations to plan challenging or age-appropriate activities. The childminder did not inform Ofsted about a significant event, to allow her ongoing suitability to be assessed.

#### Quality of teaching, learning and assessment is inadequate

The childminder does not plan activities to help children make adequate progress. She provides a limited range of resources and these are not always appropriate for the age of the children attending. For example, she provides worksheets for very young children or puzzles that are too complex. The childminder occasionally introduces new words to encourage children's language development. However, adult television programmes and background music play continuously, limiting children's ability to listen and develop their communication skills effectively. The childminder shares information with parents about children's care, but does not talk to them about what their children know and can do, and any progress they make.

#### Personal development, behaviour and welfare are inadequate

Children's welfare is compromised. The childminder does not hold a current first aid certificate to enable her to deal with accidents. She has failed to maintain required insurance and has not considered how to keep children safe while they play. She does not have an evacuation plan in the event of an emergency. Her safeguarding knowledge is weak. Children do not have daily opportunities to play outside to promote their health and physical skills adequately.

#### **Outcomes for children are inadequate**

Children are not prepared for the next stage of their learning. They lack the motivation and enthusiasm to learn, and do not develop the language skills they need. Children comply with the childminder's instructions but do not develop independent learning skills.
