Summary of key findings for parents

The provision meets requirements

- The childminder is able to confidently explain safeguarding procedures and has developed strong methods to ensure her home is safe for children. She also effectively checks risks during outings, for example, when walking to the local playgroups.
- The childminder has developed ways to involve parents and children in the evaluation of the service she provides in order to identify ways to improve.
- The childminder has effective methods to keep parents informed of their children's learning. She tracks and monitors children's progress well and uses assessments to plan fun and interesting activities to help ensure they gain skills for the next stages in their learning.
- The childminder understands how to promote respect and good behaviour. For example, she explains how she will encourage sharing and encourage children to become enthusiastic and motivated learners.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector spoke to the childminder about the service she offers.
- The inspector sampled documentation, including policies, procedures and evidence of self-evaluation.
- The inspector looked at the areas available for childminding.

The childminder registered in 2011. She lives in Feltham in Middlesex. The childminder works Monday to Friday from 6am to 6pm, all year round except for family holidays. There were no children on roll in the early years age range at the time of this inspection.
