# Summary of key findings for parents

#### This provision requires improvement. It is not yet good because:

- The provider, who is also the manager, does not ensure that staff in the baby room work fully effectively with parents, to ensure staff consistently meet the youngest children's emotional needs and care routines, especially during times of change.
- The manager does not monitor the progress of children in the pre-school room as well as possible, to identify emerging gaps in their development more promptly.
- Staff do not always extend opportunities for toddlers to do things for themselves and develop their independence.
- Since the last inspection, the manager has used self-evaluation to build on the nursery's strengths and address some areas of weaker practice. However, she is not using it effectively to focus more sharply on how to improve outcomes for all children. Not all children make good progress in their learning.

## It has the following strengths

- Staff share children's targets and progress with parents frequently, so parents can support children's learning at home.
- Children across all ages engage in enjoyable activities that motivate them to explore.
- Staff work well with outside agencies and use funding to provide children with additional engaging activities that target their individual needs appropriately.
- The manager supports staff to develop some of their skills. Children benefit from learning outdoors, which supports their mathematical and creative development well.

## What the setting needs to do to improve further

#### To meet the requirements of the early years foundation stage the provider must:

## To further improve the quality of the early years provision the provider should:

- improve the monitoring of children's progress in the pre-school room more closely to identify and close any emerging gaps in their learning promptly
- extend opportunities for toddlers to do things for themselves and develop their independence
- strengthen the self-evaluation process further to focus more accurately on improving outcomes for children.

# **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

Improved self-evaluation has helped the manager to make some changes, for example, to the planning process and range of activities for all children. However, she does not use the process effectively to monitor staff effectiveness and outcomes for children more closely. This has led to weaknesses in the baby room and monitoring of older children's progress. The manager failed to notify Ofsted of changes to her health, as required, to allow her ongoing suitability to be assessed. Safeguarding is effective. The manager and staff have sound knowledge of procedures to protect children from harm. Overall, the manager supports staff to develop their skills. Training has improved how staff communicate with the toddlers, supporting their progress in this area well.

#### Quality of teaching, learning and assessment requires improvement

Staff support pre-school children's listening and attention skills well. For example, during a game, they encourage children to share what they hear and describe the sounds to identify the hidden object. Staff in the baby room provide activities that encourage exploration. For example, babies investigate cereal using their hands and utensils to explore taste, sound and touch. However, at times, they do not always ensure babies are settled and emotionally secure, and some babies are sometimes upset due to changes in their routine, reducing their engagement in the activities. Toddlers join in enthusiastically during singing time, developing their awareness of rhythm. Children enjoy activities to explore the local woods, and engage in music and movement sessions, where they learn about the natural environment and how their bodies work when exercising. Gaps in the assessment process mean the manager is not always clear on the progress that pre-school children make, and where they need extra help.

#### Personal development, behaviour and welfare require improvement

Overall, children form close attachments to staff and seek them when they need support. However, staff in the baby room do not always engage effectively with parents, to ensure routines and changes meet the babies' care and emotional needs at all times. All children behave well, take turns and learn to share with others. Staff do not always extend opportunities for toddlers to do things for themselves during daily routines.

## **Outcomes for children require improvement**

Children become confident communicators and enjoy being active outdoors. However, minor weaknesses to the assessment process do not accurately identify pre-school children's developmental needs. Babies do not always benefit from the changes in their routines to help them settle, feel secure and benefit from the activities. All children are inquisitive and explore. They make steady progress in preparation for future learning.

Jays Day Nursery operates from Moorhaven Village in Ivybridge, Devon. The nursery registered in 1995. It is open Monday to Friday from 8am to 6pm, all year round. The nursery receives funding to provide free early education for children aged three and four years. There are 10 members of staff working directly with the children. The manager holds early years professional status, one member of staff holds a level 6 qualification, six staff hold level 2 and 3 qualifications and two members of staff are unqualified.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
