Summary of key findings for parents

The provision does not meet requirements

- The childminder has not maintained a current paediatric first-aid certificate. This is also a breach of the requirements of the Childcare Register. However, the childminder has completed some training to help her meet some specific health needs.
- The childminder knows the procedures to follow to protect children from harm. She reviews her safeguarding policies and procedures and ensures they remain up-to-date.
- The childminder has suitable procedures for working in partnership with parents and others. She knows the importance of promoting continuity in children's care and learning, and helping them feel to confident, secure and ready to learn.
- The childminder knows to provide a range of activities and resources to promote children's learning and development. She understands how children learn through play, and how to support them to achieve well and develop the skills needed for school.
- The childminder uses suitable self-evaluation processes to monitor her effectiveness and children's learning, to help her improve her practice and children's outcomes.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
