Summary of key findings for parents

This provision is outstanding

- The childminder has high expectations of children. She accurately observes and assesses their progress to plan exceptionally challenging learning experiences, which she tailors to the individual development steps of each child.
- The childminder nurtures the children in her care. She takes time to get to know children exceptionally well and sensitively responds to their care and learning needs. Children make rapid progress from their starting points.
- The childminder has a very calm manner and values children as individuals. Children form very positive relationships with the childminder. They are extremely confident, independent and have a strong sense of belonging.
- The childminder models healthy lifestyles exceptionally well. For example, children thoroughly enjoy exploring their senses as they investigate the taste, smell and feel of new fruit, such as a coconut.
- The childminder has extremely positive relationships with parents and gathers excellent information to understand children's starting points. She continues to share highly effective assessments to involve parents in their children's learning.
- The childminder is rigorous at assessing risks in all areas of her home and outings. She uses a wide range of robust procedures to ensure children are safe and secure. Young children show a strong sense of their own safety.

Inspection findings

Effectiveness of the leadership and management is outstanding

Safeguarding is effective. The childminder demonstrates an excellent understanding of the procedures to follow to safeguard children's welfare. The childminder strives to improve the high-quality provision. She uses the expert skills and knowledge she gains through training and research to develop children's learning, such as enhancing language and communication, in particular for those children with English as an additional language. The childminder meets with other childminders to share high quality practice and makes extremely successful changes that benefit children greatly. She is very keen to embrace her professional development even further, to explore more ways to enhance her inspirational teaching skills. Highly effective monitoring of the provision and children's progress helps the childminder to quickly address any gaps in learning.

Quality of teaching, learning and assessment is outstanding

The childminder is highly skilled at teaching early reading and writing. She skilfully engages children in ongoing discussion to support their developing language skills. For example, children delight in looking at photographs, which very effectively supports their emotional well-being as they recall past events. The childminder helps young children to express their ideas confidently. For example, she engages in children's play, sensitively supporting very young children to solve problems as they connect their train track together. The childminder successfully promotes children's positive respect of difference and diversity. For example, she actively encourages children to think about similarities and differences as they very enthusiastically dress their dolls.

Personal development, behaviour and welfare are outstanding

The childminder creates a welcoming and extremely exciting environment for children. She allows children to guide their own play as they choose inspiring resources to extend their interests. Very young children learn to share willingly with others. They take turns without question and have the highest respect for each other. The childminder develops children's self-esteem and independence exceptionally well. For example, she consistently promotes children's achievements and takes them on an exciting range of outings that help to develop their superb social skills. Children take part in an abundance of outdoor activities. For example, walks around nature parks, which help them to gain an extensive understanding of the natural world.

Outcomes for children are outstanding

Very young children are highly motivated and eager to learn. They confidently learn about colours, sizes and numbers during play and are eager to solve problems. All children gain the essential key skills they need in readiness for starting school.
