This provision is outstanding

- Children are provided with a fantastic range of innovative and high-quality resources. Activities are planned to excite, stimulate and challenge children's curiosity and motivation to learn.
- The childminder provides an environment that is highly nurturing and welcoming. Children's emotional and physical well-being is supported exceptionally well and they settle in quickly.
- Accurate assessment tools are used to ensure that any need for early intervention can be identified promptly. All children are making consistently high rates of progress from their starting points.
- The childminder actively involves and engages parents to establish what children can already do and celebrate their achievements together. She uses this information to plan superb experiences, to continue children's learning at the childminder's setting and at home.

Inspection findings

Effectiveness of the leadership and management is outstanding

The arrangements for safeguarding are effective. The childminder has a robust understanding of her role in keeping children safe. She clearly knows the procedures to follow should she be concerned about the safety or welfare of a child. The childminder strives for perfection and regularly seeks the views of children and parents. She uses this information to drive ongoing improvements across all areas of practice. Parents give high praise for the childminder, who they say goes above and beyond to support them. The quality of teaching is continuously reviewed and improved upon, to maintain it at an outstanding level. The highly qualified childminder attends regular training, which has further developed her understanding of how children learn. Speech and language training has successfully contributed towards the high levels of progress that children are making in this area. The childminder has identified additional ways to promote continuous professional development even further.

Quality of teaching, learning and assessment is outstanding

The environment is carefully planned to foster and ignite children's interests. The childminder promotes children's communication skills superbly, in a variety of ways. For example, she models new language, asks questions and provides children with a running commentary. Children are confident talkers and eager to share their experiences and ideas. Older children delight in exploring how the toy duck rises in the container in the water-wall activity. Younger children use a variety of tools to carefully transport water and other materials. They show excellent problem solving and critical-thinking skills. Children are given plenty of time to think through things for themselves and plan their own learning. The childminder is skilled at knowing when to offer support and when to let children work things out for themselves.

Personal development, behaviour and welfare are outstanding

The childminder plans the resources so that children can access them freely and independently. Children's views are highly valued and they feel extremely confident and self-assured. The childminder is a superb role model and gives children gentle reminders of expectations. This contributes towards children's exemplary behaviour. Children show kindness and consideration to each other and make friends easily. They show a strong sense of belonging and are developing a growing understanding of how to keep themselves safe and healthy. They are eager to join in activities and take on new challenges. Children celebrate their achievements together and develop confidence in taking reasonable risks. They learn to respect the natural world as they grow fruit and vegetables and collect the eggs from the hens. Children thoroughly enjoy their time at the childminder's setting.

Outcomes for children are outstanding

All children are thriving. They have an eager and extremely enthusiastic disposition towards learning. Children are rapidly developing key skills in all areas of learning and making excellent progress from their starting points. They are extremely well prepared for their next stages in learning and for school.
