Summary of key findings for parents

The provision meets requirements

- Arrangements for safeguarding are effective. The childminder explains how she will risk assess her premises regularly. She has a clear understanding of how to recognise any children who are at risk of harm. The childminder regularly refreshes her safeguarding knowledge and keeps up to date with changes in legislation.
- The childminder is committed to developing her practice further. She will seek the views of parents through regular questionnaires and set herself challenging but achievable targets for improvement.
- The childminder has a good understanding of how to prepare children for school. She will monitor their progress and plan varied activities and learning opportunities to motivate children to learn. The childminder has a selection of well-maintained resources for children to access.
- The childminder is well qualified and often attends training courses to develop her professional capabilities further. She intends to reflect on her learning and keep a training log. The childminder is passionate about supporting other childminders and sharing best practice.
- The childminder explains how she will have an in-depth settling-in procedure to get to know children and their families. She will spend time with families to gather information about children's routines and capabilities. The childminder will share information with parents regularly, in order to complement children's care and learning between home and the setting.
- The childminder has valid insurance and an up-to-date paediatric first-aid qualification.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector discussed with the childminder how she intends to support children's play and learning.
- The inspector looked at qualification certificates and documents the childminder will use when caring for children.
- The inspector checked evidence of the suitability of household members and talked with the childminder about her self-evaluation and improvement plans.

The childminder was registered in 1999 and lives in Hayes. She operates all year round from 8.30am to 5.30pm, Monday to Friday, except for bank holidays and family holidays. The childminder holds an appropriate qualification at level 3.
