## Summary of key findings for parents

### The provision meets requirements

- The childminder has procedures in place to reflect on her practice and identify ways to improve her provision. She recognises that this helps her to make changes and provide better outcomes for children.
- The childminder knows how to observe, assess and plan for children's learning and development, along with parents and others involved in children's development, to help prepare children for school.
- The childminder has a secure understanding of child protection and recently completed safeguarding training. She understands her responsibility in protecting children from harm and keeping them safe at all times.
- The childminder recognises the importance of promoting positive behaviour and teaching children to be tolerant, and value and respect differences between themselves and people in wider community.
- The childminder understands how to promote children's health and well-being; for example, by providing regular exercise, and healthy and nutritious food for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector talked to the childminder about her practice and understanding of the requirements.
- The inspector checked the areas and resources within the childminder's home intended to be used for childminding.
- The inspector sampled some of the childminder's documentation.
- The inspector discussed the childminder's self-evaluation procedures and her improvement plans.
