The provision meets requirements

- The childminder maintains a range of policies and procedures to help keep children safe. She knows how to refer a concern about a child's welfare to protect them from harm.
- The childminder knows how to promote children's learning in all areas. She has a range of resources that she uses to promote children's development and help them progress.
- The childminder understands the importance of helping children to develop respect and build good relationships. She knows how to promote children's independence to help them prepare for school.
- The childminder is aware of how to promote children's awareness of healthy lifestyles. She provides children with healthy snacks and meals and physical exercise.
- The childminder places importance on the self-assessment process to improve her knowledge, understanding and practice. She reviews her systems regularly to update herself about any changes in legislation and childcare practice.
- The childminder knows how to monitor children's learning and development and secure appropriate interventions so that children receive the support they need. She recognises the benefits of sharing information with parents and other professionals to help her meet children's individual needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
