Summary of key findings for parents

This provision is outstanding

- The childminder's dedication and enthusiasm to continually enhance children's learning and provide high-quality care are exceptional. She uses her knowledge of the children's abilities and learning styles to plan activities that capture their interest and motivate them to learn.
- The childminder completes clear and concise observations of children in planned and spontaneous play situations. Her exceptional tracking of children's abilities enables her to swiftly identify where progress is less than expected or higher and so plan effectively to close gaps or provide extension to learning.
- The partnerships with parents are excellent. The childminder values parents as partners and places great emphasis on working in true partnership with them. Communication between home and the childminder is superb. Parents are continually involved in their child's learning and the childminder shares resources to enable children's learning to continue at home.
- The childminder is highly skilled and sensitive in helping children to form secure emotional attachments and feel safe and secure in her care. She supports them extremely well as they develop their independence and share their ideas.
- Children play in an extremely safe and secure environment. They are fully aware of the emergency evacuation procedure to follow in the event of a fire and learn safe routines for crossing the road when out.
- Children's language and communication skills flourish. The childminder is attentive and seizes every opportunity to help children think more deeply, recall and extend their language.

Inspection findings

Effectiveness of the leadership and management is outstanding

The arrangements for safeguarding are effective. The childminder is extremely knowledgeable about her role and responsibility in protecting children from abuse and neglect and the procedures to follow if concerned about a child in her care. The childminder works closely with her assistant to ensure that new information and changes in practice and legislation are reflected in their service they provide. Self-evaluation is highly effective. The childminder has identified the potential for children's learning outdoors to be further enhanced through time spent exploring the natural world in their local community and woodland areas. Parents share excellent feedback about the care, learning and support they and their children receive. They comment on how their children thrive in the childminder's care and thoroughly enjoy every second with her.

Quality of teaching, learning and assessment is outstanding

The childminder has high expectations of what children can achieve. She inspires children to learn through the interesting activities and play opportunities provided. Children concentrate deeply as they count, sort and work out shape. They create their own pictures identifying different shapes and matching colours to a specific shape, such as a pizza or the sunshine. Children are inquisitive about the living world. They delight in discovering a snail in the garden, locating appropriate bedding and observing closely to see how it looks and moves. They show intrigue as the childminder places it onto her hand. They talk about its shell and antennae and compare the differences between the snail and a slug. Children's love of books blossoms. They relish the time sitting with the childminder reading. She makes this time exciting and changes her voice to reflect characters and to create excitement. Children delight in helping her to read, finishing sentences and recalling the story in their own words afterwards.

Personal development, behaviour and welfare are outstanding

Children are confident and self-assured. The bond between them, the childminder and each other is extremely strong. The childminder promotes children's emotional well-being superbly, ensuring that time is spent gradually getting to know each child and their needs. Children's physical development is extremely well promoted. They relish their time outdoors and the garden is an extension to their learning experiences. The childminder is vigilant about the safety of the children. They also play an active role in identifying risks. They use laminated pictures of different risks they may see in different situations. The childminder supports them to complete their own assessments, listening to what they have to say and taking appropriate action to minimise any risks. Behaviour is excellent. They learn to negotiate as they play as they value and respect each other.

Outcomes for children are outstanding

Children are making excellent progress in all areas of their development. They are enthusiastic, inquisitive learners. They show high levels of concentration, taking great care when painting their pictures of the sunflowers. They develop outstanding skills and levels of independence in readiness for the move to nursery or school.
