Summary of key findings for parents

This provision requires improvement. It is not yet good because:

- The childminder has failed to complete Disclosure and Barring Service checks for all persons living on the premises as required. However, the impact on children's well-being is significantly reduced as the childminder never leaves them unsupervised. This is also a breach of the Childcare Register.
- The childminder's system for monitoring children's progress is not thorough enough to precisely identify all gaps in learning. This does not help her to sharply focus planning for individual children's next steps.
- The childminder does not always support children to be fully independent. For example she sometimes does things for children that they could do for themselves.
- The childminder does not always offer children opportunities to explore and investigate sensory activities to help develop their creativity.

It has the following strengths

- The childminder offers a warm and welcoming environment and children build good relationships with her which help them feel secure.
- The childminder supports children's interests and provides opportunities for them to explore them, in specific regards to letters and letter sounds. Children have good literacy skills and can identify letter sounds to spell some words.
- The childminder has good relationships with parents and works in partnership with them to share children's care and learning and help support consistency.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

To further improve the quality of the early years provision the provider should:

- improve opportunities for children to build on the independence skills to help them prepare for the next stage in their learning
- give a wider range of different materials to further support children's creative development.

Inspection activities

- The inspector completed observations of the children engaged in activities with the childminder.
- The inspector sampled some of the documents that the childminder uses to support his practice.
- The inspector held discussions with the childminder at convenient times during the inspection.
- The inspector obtained written feedback from parents to gather their views of the provision.
- The inspector viewed all areas of the home used for childminding.

Inspection findings

Effectiveness of the leadership and management requires improvement

Safeguarding is effective. The childminder has a good understanding of safeguarding procedures and knows how to refer a concern regarding a child's welfare. However, the childminder has not completed a suitability check for a household member, although they do not have unsupervised access to children. The childminder completes regular risk assessments for inside and outside her home, this helps her to minimise possible hazards to children. The childminder completes regular dutted with current legislation and practice. She includes the views of parents and children in the self-evaluation of her setting, to help her make well-targeted improvements.

Quality of teaching, learning and assessment requires improvement

The childminder does not use the information gained from her observations to precisely monitor children's learning and identify their next steps in learning. This does not help her to sharply plan activities or opportunities for children to fully support gaps in their development. The childminder effectively supports children's communication and language development and uses interesting resources. For example, the childminder uses interactive three-dimensional flash cards to help support awareness of letters and their sounds. The childminder extends children's learning through play and stories. For example, children identify colours while reading stories. The childminder does not always offer opportunities for children to explore their senses to help support their creativity.

Personal development, behaviour and welfare require improvement

Children form secure relationships with the childminder and they enjoy the interactions. The childminder supports and encourages children's behaviour effectively. For example, the childminder has a good awareness of how to manage different children's individual behaviour needs. She completes care routines appropriately and hygienically; however, she does not fully support children's independence skills. For example, she cleans their hands and face for them and she does not always offer children choices in their play to help support their skills for their future learning. The childminder supports children's physical well-being effectively; for example, she takes children on outings within the local community and to parks.

Outcomes for children require improvement

Children do not always make the best possible progress. Children are happy and confident in the childminder's care. They are developing some of the skills they will need for the next stage in their learning, including school, with particular regard to literacy and mathematical skills.
