## Summary of key findings for parents

### This provision is outstanding

- Leaders and managers have made excellent progress since the previous inspection to improve practice to the highest standards.
- Leaders and managers respond very effectively to the views of staff, parents and children to evaluate practice and introduce highly successful initiatives.
- The acting manager sets high standards for the staff team, ensuring that children receive the best care and support in this very welcoming and inclusive club.
- Children benefit significantly from the highly stimulating play environment where they have a very wide choice of activities that fully capture their interest.
- Staff develop very good relationships with children. Children show that they feel very secure and are confident to share their feelings and any concerns.
- Children demonstrate an excellent understanding of behavioural expectations. They play exceptionally well together and respond very well to staff.
- Staff are highly effective in helping children to develop an excellent understanding of healthy lifestyles and staying safe.
- Children have very good opportunities to develop their confidence, to respect others and to learn about people who are different from themselves.
- Parents report that children thoroughly enjoy attending the club and experience a very wide range of creative and exciting activities.

## What the setting needs to do to improve further

### To further improve the quality of the early years provision the provider should:

- extend opportunities further for children to develop their abilities to listen intently and to be highly responsive to others.

- The inspector observed activities indoors and outdoors.
- The inspector completed a joint observation with the acting manager.
- The inspector checked evidence of suitability and qualifications of staff working with children.
- The inspector took account of the views of parents and carers spoken to on the day and from information included in the club's own parent questionnaires.

## Inspection findings

### **Effectiveness of the leadership and management is outstanding**

Leaders and managers have responded exceptionally well to the action and recommendations set at the previous inspection. Safeguarding is effective. All staff now receive safeguarding training routinely. They review their procedures continuously to secure a high level of understanding of how to identify and respond to concerns. An excellent focus on professional development enables staff and managers to improve their skills and knowledge very successfully. For example, training in play work has helped all staff to extend activities much more effectively to help children become highly engaged in their play. Partnership working with parents is excellent. Staff have a very high regard for parents' views and respond exceptionally well to their suggestions. For example, following parent questionnaires, staff have introduced a wide range of exciting science experiments that stimulate children's curiosity very effectively. The team's approach contributes to highly effective self-evaluation. Staff plan to continue a rolling programme of new and exciting activities to maintain children's high levels of motivation.

### **Quality of teaching, learning and assessment is outstanding**

Leaders, managers and staff have worked exceptionally hard to provide a much-improved play environment and exciting experiences. The range of resources and activities is outstanding. Staff choose to reflect very successfully all the areas of learning that children experience in school. Their approach, together with very close partnership working with parents and the on-site school, leads to high levels of continuity in children's development. Children show high levels of concentration as they engage in creative activities, learn about the world around them and practise their physical skills. For example, they become highly engrossed making Egyptian necklaces, as staff help them to absorb new information and make links in their learning.

### **Personal development, behaviour and welfare are outstanding**

Children develop high levels of confidence, such as taking turns to talk about their experiences within a large mixed-age group. They listen to each other well for most of the time and the acting manager is aware of the need to extend opportunities to practise listening skills further. Staff place a high emphasis on helping children learn about healthy lifestyles, responding very effectively to their suggestions. For example, they now provide twice weekly cooking sessions at children's request and make nutritious meals, such as soup and fruit kebabs. Staff are dedicated to helping children respect people who are different from themselves. For example, they embrace the different home languages of attending families, regularly celebrate cultural festivals and reflect children's experiences in very well-presented displays and photo books.

Earlyworld Kids Club (Eynsham Community Primary School) is one of seven settings run by Earlyworld Ltd. It registered in 2010. The club operates from the children's centre within the grounds of Eynsham Community Primary School in Eynsham, near Oxford. It also has use of the school playing field and swimming pool. The club is open on weekdays during school term times. It provides a breakfast club from 7.30am until 8.45am and an after-school club from 3pm until 6pm. During school holidays, the club operates daily from 8.30am until 6pm. The club employs seven staff, five of whom hold relevant qualifications.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
