Summary of key findings for parents

The provision meets requirements

- The childminder understands his role to safeguard children, and the action to take if he had any concerns. He attends regular training to ensure his knowledge is current.
- The childminder has a range of resources to support children's learning and development. The childminder understands his role in planning activities to meet children's individual needs, and to help prepare them for moving on to school.
- The childminder understands his role in making observations and assessments of children's learning and development. He understands the need to work with parents and any other professionals connected with children.
- The childminder plans to teach children to respect each other, take turns and share resources. He plans to promote good behaviour, and a healthy lifestyle with nutritious meals and daily exercise.
- The childminder understands the use of reflection and self-evaluation. He plans to include the views of others in his reflections, and when planning any developments.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector and childminder discussed the requirements of the early years foundation stage.
- The inspector viewed areas of the house and garden used for childminding.
- The inspector sampled relevant documentation, including suitability checks.

The childminder registered in 2009. He lives in Fareham, Hampshire. The childminder offers care Monday to Friday, from 7am to 6.30pm throughout the year. The childminder has a recognised early years qualification at level 3. There were no children of early years age present at the time of inspection.
