## Summary of key findings for parents

#### The provision does not meet requirements

- The provider does not meet all the requirements of the Early Years Register and the Childcare Register. She does not ensure there is always at least one person with a relevant first-aid qualification deployed effectively to respond to emergencies quickly.
- The provider does not keep an accurate record of children's attendance, as required. She does not fully investigate or respond to complaints within the required timeframe.
- The provider and her staff have completed safeguarding training. They know the signs to look for and the procedures to follow if they have concerns about a child's welfare.
- Staff know how to plan and provide a range of interesting activities. There is a variety of resources and age-appropriate equipment available for children to choose from.
- Staff know how to help children understand behavioural expectations. They understand how to promote children's independence, self-esteem and physical development.
- The provider understands the importance of gathering information from parents and teachers to support and complement children's individual needs.
- The provider is developing a process of reflective practice and considers the views of parents and children when evaluating the setting.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

Churchill Kids Club registered in 2008 and is managed by a committee. The club mainly operates from the school hall and key stage one lobby; however, all areas of the school are used to provide care. Children have use of the fully enclosed playground, school field and activity area. The club operates for the exclusive use of children attending the school. The club operates daily during term time from 7.45am to 9am and from 3.30pm to 5.45pm. The club employs three members of staff; two of these have appropriate qualifications at level 3 and one is unqualified. On the day of the inspection, there were no children within the early years age range present.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
