The provision meets requirements

- The manager understands her responsibilities to safeguard children. She has a range of procedures for staff to follow should they be concerned about a child's welfare.
- The manager and staff evaluate their practice and reflect on the quality of the setting. For example, staff attend training to develop their knowledge and skills.
- Staff understand how to create a welcoming and safe environment. For example, they know how to plan interesting experiences to match children's individual interests and to support their enjoyment.
- Staff understand how to manage children's behaviour and to be positive role models. For example, know how to help children learn to respect one another.
- The manager understands how to work in close partnership with parents and other professionals, to provide consistency in children's care experiences.
- Staff know how to help children acquire the necessary skills, in preparation for their future education.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector spoke to the manager about the club's policies and procedures, including how she intends to meet the safeguarding and welfare requirements.
- The inspector viewed the areas of the premises that are available for children and discussed safety arrangements.
- The inspector looked at relevant documentation and records that the manager plans to use to support children's welfare.
- The inspector discussed with the manager her systems for self-evaluation.

It operates for two or three days a week, from 9.30am to 4pm, during the school holidays and on some Saturdays. The provider employs 25 full and part-time staff. The manager holds a relevant qualification at level 7. There were no children on roll in the early years age group during this inspection.
