Summary of key findings for parents

This provision is inadequate

- Staff do not always ensure younger children's safety. Risk assessments for babies are not thorough enough to ensure that all risks and hazards are minimised.
- Systems to develop the knowledge and skills of staff are ineffective. Induction does not ensure that staff are familiar with their roles or the policies and procedures. Supervision does not address weaknesses in teaching and support staff to improve their effectiveness.
- Procedures to meet children's individual needs with regards to nappy changing are ineffective. Staff are not vigilant enough to recognise when children need to be changed. Furthermore, it is not always clear if children and babies wearing nappies have been checked or changed regularly.
- Teaching is weak. Staff do not know the children well enough to support their learning. Staff interaction is mundane and largely supervisory. Staff fail to build on what children already know.
- The partnership with parents and carers is not suitably developed. Parents and carers are rarely provided with information about their children's learning and development. Staff do not encourage them to share contributions of children's learning from home.
- Staff deployment is poor. Staff frequently hold discussions about what they are doing now or next, while children are waiting. The disorganisation of some routines causes children to be bored or unsettled.

It has the following strengths

■ Staff are friendly with the children. They reassure and comfort them when they are upset.

Inspection activities

- The inspection was carried out following the risk assessment process when concerns were raised about the provider's ability to meet requirements.
- The inspector observed the quality of teaching during activities indoors and outdoors, and assessed the impact this has on children's learning.
- The inspector completed joint observations with the deputy manager.
- The inspector held a meeting with the deputy manager and nominated person. She looked at relevant documentation, such as evidence of the suitability of staff working in the nursery.
- The inspector spoke to a small selection of parents and carers during the inspection and took account of their views.

Inspection findings

Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are ineffective. Staff working with the babies do not ensure that children cannot access items that may pose a risk to their safety. Furthermore, they use resources during activities that are not appropriate. Induction is ineffective. There are a number of new and relief staff who are working with children that they are not familiar enough with. In addition, the management team does not ensure that staff have a secure knowledge of the policies and procedures. Supervision does not thoroughly evaluate teaching and identify what needs to improve. Furthermore, staff do not receive appropriate support to develop their knowledge and skills. The management team has started to evaluate the practice within the nursery. However, they have not yet prioritised the actions for improvement or identified how and when they will be completed. Staff work in partnership with schools to effectively support children as they move on from the nursery. The management team undertakes appropriate checks on staff to establish their suitability to work with children. The recording of accidents is accurately maintained and shared with parents.

Quality of teaching, learning and assessment is inadequate

The quality of teaching is poor. Most staff watch children as they play and comment on what they are doing. However, they do not engage them in play or support their learning. Staff do not make use of children's interests or learning needs to plan appropriate activities. When staff deliver planned activities they do not help children to develop or extend their learning. They sometimes repeat activities, such as games, several times without any variation. Changes to staffing mean that parents and carers do not always know who their children's key person is. Staff do not often share information about children's learning with their parents or carers, nor do they encourage parents and carers to share information about children's learning at home. Staff do discuss how to support children with English as an additional language with parents and carers. This enables a consistent approach to helping children to learn English.

Personal development, behaviour and welfare are inadequate

Staff do not always meet children's care needs with regards to nappies. The organisation of staff is not effective in ensuring the smooth delivery of activities and routines. Staff are frequently deciding what to do next or who is doing what. This impacts on children being unsettled within their room, particularly with regard to the younger children. This also has an impact on children's learning and development because some activities are not properly resourced. Most children behave well, in spite of the lack of interaction. Staff manage unwanted behaviour reasonably well. Children have daily opportunities to play outdoors and experience fresh air and exercise.

Outcomes for children are inadequate

The poor quality teaching means that children do not make sufficient progress in their learning and development. Children can be very quiet during play as they are not encouraged to develop their communication skills. Children often wander around the room or repeat the same actions to occupy themselves. Younger children struggle with

frustration as they often want a toy another child has, due to the lack of stimulation. Children are not developing the skills they need for their future learning.

Sunny Days Nursery was registered in 2015. The nursery employs 14 members of childcare staff, of these 12 hold early years qualifications at level 3. The nursery opens from Monday to Friday all year round. Sessions are from 7.30am, until 6pm. The nursery provides funded early education for two-, three- and four-year-old children. It supports children who speak English as an additional language.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
