Summary of key findings for parents

The provision meets requirements

- The childminder has successfully met the actions and recommendations from her previous inspection. She intends to use the information she gathers about children's learning to assist her in planning further activities and to help shape her teaching. The childminder described how she evaluates her provision and how she intends to share information with other settings children may also attend.
- The childminder has a sound understanding of child protection procedures and knows the steps to take to protect children in her care.
- The childminder has established house rules to help her positively manage children's behaviour. She explains how she plans to work in partnership with parents to help provide consistency in children's care.
- The childminder demonstrates a sound knowledge and understanding of the learning and development requirements of the early years foundation stage. She understands how activities, toys and resources can help to support children's progress.
- The childminder spoke about how she intends to use a gradual settling-in procedure for new children. For example, she described the information she plans to gather from parents. The childminder talks about encouraging children to bring familiar toys and comforters from home to help them settle.
- The childminder demonstrates her good knowledge and understanding of providing nutritious snacks and meals. She gave examples of considerations she plans to make for allergies and diet-related illnesses.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
