Summary of key findings for parents

The provision meets requirements

- The childminder understands how younger and older children learn. She knows how to plan a range of activities to promote all areas of their learning.
- The childminder has had training in food safety. She understands the hygiene procedures to follow while preparing children's snacks and meals. She plans to work in partnership with parents to help children develop healthy eating habits.
- The childminder uses self-evaluation to identify areas for improvement. For example, she has reviewed and made changes to her observation, assessment and planning process since the last inspection. She has improved the garden area to help stimulate children's enjoyment in playing outside.
- The childminder has developed processes for risk assessment to ensure the premises are safe for use by the children. She understands the safeguarding procedures set out by her local authority, to make referrals should she be concerned about children's welfare.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed areas of the premises that the childminder intends to use for childminding, including outside areas.
- The inspector assessed the childminder's safeguarding policies, practice and procedures.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at a sample of documentation and a selection of policies and procedures.

The childminder registered in 2011. The childminder lives in Morden, in the London Borough of Merton. The childminder offers care all day, Monday to Sunday and offers overnight care. There were no children on roll at the time of inspection.
