Summary of key findings for parents

The provision meets requirements

- The childminder has a secure knowledge of the early years requirements. She understands how to observe and check children's progress, plan for the next stage in their learning and prepare them for school.
- The childminder knows how to provide a secure and welcoming environment for children. She knows how to help children learn to respect each other and how to behave. The childminder has a suitable range of resources to meet their needs.
- There are clear routines to safeguard children. The childminder knows what to do if she has concerns about a child in her care and the procedures to follow.
- The importance of working in partnership with parents and other professionals to provide continuity in children's care and learning is well understood.
- The childminder knows how children's good health is promoted. For example, she is aware of the need to promote children's good hygiene and their physical exercise.
- The childminder understands how professional development and evaluating her service carefully can help her to identify areas that might need improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the areas of the premises that are available for children's use.
- The inspector looked at some documents and discussed policies, which the childminder uses when caring for children.
- The inspector discussed with the childminder how she intends to promote children's learning and development.
- The inspector discussed with the childminder how she intends to meet the welfare requirements when children attend.
- The inspector discussed self-evaluation with the childminder.

The childminder registered in 2000. She lives in Wembley in the London Borough of Brent. The childminder works with another childminder. The childminder mainly works during school holidays only. There were no children on roll at the time of the inspection.
