Summary of key findings for parents

The provision meets requirements

- The provider understands how to manage children's behaviour, and to teach them to listen to and respect each other's views.
- The provider is aware of how to safeguard children. She encourages staff to keep up to date with changes to legislation. She understands the need to make sure the areas children play in are safe.
- The provider understands the importance of self-evaluation. She works with staff, children and parents to review practice and activities on offer. For example, children regularly share their views and staff build on these to improve activities. The provider recognises this helps the staff to support children's enjoyment.
- The provider is aware of the need to engage children during their play. For example, staff and children work together to plan activities and use children's interests. The provider understands that this helps children to enjoy their time at the club.
- The provider provides nutritious snacks and encourages children to have healthy lifestyles. For example, daily plans include exercise and sport activities.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector reviewed areas used for children to use.
- The inspector had discussions with the provider about her practice and that of her staff.
- The inspector reviewed relevant documents, including safeguarding and risk assessments.

Funkidz Club - St Luke's registered in 2011. It operates from the main hall and other rooms in St Luke's church complex in Rochester, Kent. The club provides care out of school hours and is open Monday to Friday, from 8am until 6pm, during school holidays only. There are five members of staff, all of whom hold childcare qualifications to level two and above. This includes the manager who holds early years professional status. There were no children on roll at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
