## Summary of key findings for parents

#### This provision requires improvement. It is not yet good because:

- Some staff do not have a full understanding of how to thoroughly complete risk assessments, particularly in the outdoor area. This leads to minor hazards, such as brambles, not being identified.
- Staff are not always deployed effectively to meet the care and learning needs of all the children in their care.
- Staff do not always plan activities that are age appropriate and which extend children's learning. Children do not always make good progress from their starting points.
- Managers do not always effectively monitor practice to make sure that all staff have a full knowledge of their roles and responsibilities.

### It has the following strengths

- Close bonds and secure attachments are evident between staff and children. This helps children to be emotionally secure, develop into active learners and be keen to explore.
- Staff are good role models and use consistent behaviour strategies. They encourage children's understanding of sharing and good behaviour through explanation and discussion. Children behave well.
- Parents are well informed about the progress their children make. Staff and parents share information about children's development and work well together to support children's learning in the nursery and at home.

## What the setting needs to do to improve further

strengthen methods used to monitor staff and identify weaknesses in their practice to ensure they fully understand their roles and responsibilities.

- The inspector observed activities and the quality of teaching indoors and outdoors.
- The inspector sampled a range of documentation, including key policies and procedures, the self-evaluation form and children's development records.
- The inspector took account of parents' views.
- The inspector spoke to members of staff and children at appropriate times during the inspection.
- The inspector held meetings with the acting manager, nominated person and head office team, and completed a joint observation with the acting manager.

## **Inspection findings**

#### Effectiveness of the leadership and management requires improvement

Managers do not fully monitor and support staff to ensure they have a thorough understanding of their role and responsibility. For example, staff understand basic risk assessment but do not fully understand how to thoroughly assess all areas, particularly the outdoors. They had not identified minor hazards, such as nettles and brambles. Safeguarding is effective. Management and staff have a thorough awareness of child protection matters and understand the procedures for reporting any concerns they may have about an individual child or a member of staff. Managers include the views of staff and parents in their effective self-evaluation process to help identify areas for development. Staff extend their knowledge through, for example, attending management meetings and in-house training. They have improved their understanding of the planning, observation and assessment system. Managers review children's progress and have bought resources to help them catch up where there are gaps in their learning.

#### Quality of teaching, learning and assessment requires improvement

Staff plan and provide a varied range of activities. However, on occasions, these can be too challenging and children lose interest. For example, staff read books to young children with complex stories and too many words for them to understand. Staff observe children so they know what they can do to support them in their next steps of learning. However, due to inconsistent monitoring of staff practice some assessments of children's development are not as precise as others. Since the previous inspection, the staff have reviewed the environment and made writing equipment and musical instruments more accessible to the children. For example, babies develop their early writing skills as they draw lines using crayons.

#### Personal development, behaviour and welfare require improvement

Staff form very strong bonds with the children, particularly the babies. However, at times they are not deployed well enough to support all the needs of the children. For example, when the staff have to settle babies the other children's needs are not fully met. Children are supported with their move to school. Good links with the local children's centre enable staff to use additional resources to extend children's understanding of the new school environment and routine. Children play in a well-resourced and interesting environment where they have regular access to the outdoor areas to fully extend their physical skills.

#### **Outcomes for children require improvement**

Children are mainly happy and settled, but they do not all make consistently good progress. They show confidence when choosing resources and deciding where they want to play. Children use their imaginations well. For example, they talk about the price and how much petrol they need as they pretend to fill the cars from the petrol pump.

Umbrella Nursery is owned by Alpha Nurseries Ltd and operates in Dover, Kent. The nursery is open five days a week from 8am to 6pm for 52 weeks of the year, closing on bank holidays. There are 14 qualified members of staff working directly with the children. This includes the manager who holds a level 4 qualification and nine staff holding level 3 qualifications. The nursery receives funding to provide free early education for children aged two, three and four years.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
