Summary of key findings for parents

The provision meets requirements

- The childminder demonstrates a secure knowledge of how to develop children's learning. He understands the need to plan activities to cater for children's individual learning needs and help prepare for what they might need to learn next.
- The childminder knows the importance of establishing partnerships with parents and other professionals, to have a shared approach to meeting children's needs.
- Maintaining children's good health and of developing their understanding of healthy lifestyles is well understood by the childminder. He knows the need to provide the children with regular opportunities outdoors and for physical activity.
- Reflective practice and self-evaluation to help identify the strengths and areas for further improvement is a clear part of the childminder's approach.
- The childminder has a good understanding of how to foster children's positive behaviour and respect of others.
- Child protection procedures are well understood by the childminder. He knows how to report any concerns to the relevant agencies. He maintains a safe and secure environment which is suitable for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder his understanding of the requirements of the early years foundation stage and how he intends to meet these when children attend in the future.
- The inspector and the childminder looked at the areas and resources available for children's use.
- The inspector discussed with the childminder how he would deliver the educational programmes when caring for children and undertake observation, assessment and planning.
- The inspector looked at and discussed a range of records, policies and procedures with the childminder.
- The inspector discussed safeguarding procedures and how the childminder intends to keep children safe.

The childminder registered in 2014. He lives with his registered co-childminder in Peckham in the London Borough of Southwark. He operates from Monday to Sunday all year round. There were no children in the early years age range on roll at the time of the inspection.
