Summary of key findings for parents

This provision is outstanding

- Staff form excellent relationships with children and their parents. Their attentive, caring and nurturing approach help children settle quickly into the daily routines and make friends. Children develop a very strong sense of community and self-worth.
- All children make outstanding progress in relation to their different starting points. Children who learn English as an additional language, or receive extra support, equally make outstanding gains in their learning. Children are exceptionally well prepared for the next stages in their learning, including starting school.
- Children have excellent opportunities to broaden their understanding of the different people and their cultures. For example, they enjoy taking part in different festivals and use the world map to find out about countries where certain people might come from.
- Highly effective partnerships with parents and outside professionals enable an excellent joint-approach to the care and support for individual children.
- Parents are overwhelmingly positive about the service they receive; they feel that their children are very happy and learn exceptionally well.
- The Senior Management Team has very high expectations of what children can achieve. For instance, they supervise and set challenging targets for staff. They consistently assess and evaluate the provision to help children receive a superb and highly beneficial experience.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

■ explore other ways to help older children develop their physical skills even further.

Inspection activities

- The inspector observed activities in all parts of the nursery, including the outdoor provision.
- The inspector spoke to some members of staff and children at appropriate times during the inspection and held meetings with the nursery management team.
- The inspector conducted joint observations with a member of the Senior Management Team.
- The inspector took account of the views of parents spoken to during the inspection and reviewed parents' written comments and suggestions.
- The inspector looked at children's records, planning documentation and the nursery's policies and procedures, including those related to the suitability of staff.

Inspection findings

Effectiveness of the leadership and management is outstanding

The Senior Management Team and staff expertly implement the early years foundation stage requirements. They closely meet each child's individual needs and check the achievements of different groups carefully to ensure that all children make substantial and sustained progress. Safeguarding is effective. Robust recruitment and induction procedures help ensure that staff are suitable for the role. Staff have an excellent knowledge of the safeguarding practices. For example, they are very clear about the procedures to follow to safeguard children in their care. The Senior Management Team and staff actively develop highly successful safeguarding awareness in the local community. Adults make exceptional use of knowledge and skills they have learnt, such as in training or through observing others, to fully benefit children's learning. The Senior Management Team acts seriously on the information gained from staff, parents, children and others to continually evaluate and improve their practice.

Quality of teaching, learning and assessment is outstanding

Staff and the Senior Management Team have an excellent understanding of how children learn and develop. They gather a wealth of information on children's development and use it extremely well to meet the specific needs, abilities and interests of individual children. Children benefit extremely well from a wide range of memorable experiences that inspire them to learn. Children of different ages have a thirst for knowledge. For instance, they thoroughly enjoy acting out their favourite stories to capture their friends' attention. They frequently make 'wow' comments on what they see, feel, smell or taste, reflecting their enthusiasm.

Personal development, behaviour and welfare are outstanding

Staff are excellent examples to children in how to treat others. They talk to children calmly and encourage them to express their feelings freely. Children play extremely well and are courteous to others. They share resources fairly and tidy up toys without a reminder. Their behaviour is exemplary. Children have an excellent knowledge of healthy eating. For example, they know that some fruits contain certain nutrients that can help people remain healthy. Children have superb opportunities to have outside-based exercise. However, the Senior Management Team recognises that on occasions the physical skills of the older children could be enhanced even further. Staff conduct robust and regular checks on the premises and help children manage safety risks that are appropriate for their age.

Outcomes for children are outstanding

Children make outstanding progress and any gaps in their learning compared to others, close rapidly. Babies learn new words and explore fun activities safely. Children become increasingly confident and independent learners. Older children count objects, recognise numerals and significantly increase their problem-solving skills. They use their knowledge of letters and sounds to write their names correctly and to read many complex words.

The Little Learners Montessori Northwood registered in 2014. It is one of four nurseries owned by a private provider. The nursery is located in the London Borough of Hillingdon. It is open each weekday from 7.30am to 6pm and operates all year around except bank holidays. The provider receives funding to offer free early education for children aged two, three and four years. There are 13 members of staff, one of whom holds early years professional status. The remaining 12 staff have appropriate early years qualifications ranging from level 2 to level 6. The nursery follows the Montessori educational philosophy.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
