Summary of key findings for parents

The provision does not meet requirements

- The childminder fails to maintain a daily record of children's hours of attendance to promote their welfare. This breach also relates to the requirements of the Childcare Register.
- The childminder has an understanding of her role in keeping children safe, including following child protection procedures and acting promptly to safeguard children.
- The childminder is knowledgeable about how to carry out observation and assessments to support children's play, including how to use this information to inform her planning of children's activities.
- The childminder understands how to support children's progress, including ways to extend their language, communication and early literacy skills.
- The childminder recognises the importance of developing partnerships with parents, and supporting them to contribute to children's next steps in learning.
- The childminder knows how to evaluate her service. For example, she seeks support and guidance from external agencies.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the early years foundation stage and the Childcare Register the provider must:

The childminder registered in 1992. She lives in Chadwell Heath, in the London Borough of Redbridge. The childminder provides care during weekdays and operates all year round. There were no children present at the time of the inspection.
