Summary of key findings for parents

This provision is good

- Senior staff members are dedicated and knowledgeable. They are ambitious and have high expectations of all staff.
- Accurate self-evaluation is used to continuously improve the provision. The manager targets specific areas for further development to have a positive impact on the learning experiences of the children.
- All nursery staff are enthusiastic and motivated. They make regular and accurate assessments of children's progress, helping them tailor their teaching to the needs of each individual child.
- Staff in the baby room are particularly knowledgeable about how very young children learn. They are very successful in supporting the personal development and learning of the youngest children.
- The nursery offers a caring and stimulating environment. Children progress well, are eager to learn and share that learning with others.

It is not yet outstanding because:

- Occasionally, staff do not grasp all opportunities to extend children's vocabulary in order to support their language development as fully as possible.
- Some staff are more confident than others in their ability to consistently support the positive behaviour of children in the nursery.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- develop the ability of staff to consistently support children in extending their vocabulary as fully as possible during activities
- devise ways to ensure all staff have the confidence to adapt the strategies they use to support positive behaviour, when necessary.

Inspection activities

- The inspector observed a variety of outdoor activities throughout the nursery.
- The inspector undertook a joint observation with the manager.
- The inspector talked to parents, staff and children to gather their views.
- The inspector held a meeting with the nursery manager.
- The inspector looked at a selection of policies, children's records, documents relating to the suitability of staff and the nursery's self-evaluation document.

Inspection findings

Effectiveness of the leadership and management is good

Safeguarding is effective. Staff complete related training and are secure in their knowledge of the signs and symptoms which may cause concern. They know the procedures to follow if they are concerned about the welfare of a child in their care. Rigorous recruitment and induction procedures are carried out by the manager to check that staff are suitable to work with children. The manager has ongoing plans to improve specific areas within the nursery. For example, by creating a sensory room to enhance the children's learning experiences. Staff's professional development is supported well, for example, by regular training. Their learning is used to improve practice in the nursery. The manager monitors staff performance and quality of teaching. This supports the children in making good progress. The manager makes good use of additional funding to meet children's individual needs.

Quality of teaching, learning and assessment is good

When joining the nursery, children's starting points are quickly and accurately assessed. All children's progress is closely monitored and their next steps in learning carefully planned. Any areas of children's learning that may require additional support are quickly identified and staff plan targeted activities to support that learning. This improves outcomes for all children. Staff are skilled at observing children and extending their developing interests. Children benefit from interesting learning opportunities. For example, in the baby room staff recently organised a very successful beach-themed day, transforming the room to feel like the seaside. Staff work closely with parents and regularly share information about their child's learning and progress, which parents say they value.

Personal development, behaviour and welfare are good

The key-person system works very well and children form good relationships with staff who are warm and caring. Children are happy to come into the nursery. They are helped to understand about how others feel and are taught to share and take turns. They have many opportunities to go out and learn about their local area and community. For example, children enjoy visiting a local park for a picnic. Children learn about healthy eating and meals; snacks and drinks provided support this which are appealing and nutritious. Risk assessments are carried out and children kept safe. For example, children going on an outing wear hats in the sun.

Outcomes for children are good

Children confidently explore different resources and play areas. They are eager to share their activities and learning. All children make very good progress from their starting points. They have fun, enjoy mixing with others and are prepared well for moving on to school.

The nursery receives funding for children aged two years. There are 20 members of staff; of whom, one holds early years professional status and 15 hold relevant qualifications from level 3 to level 6.
