Summary of key findings for parents

The provision meets requirements

- The childminder understands her role to safeguard children. She has knowledge of child protection issues and the procedures to report any concerns about children's welfare to the relevant authorities.
- The childminder knows how to implement a wide range of policies and procedures to ensure children and their families have positive experiences. For example, she knows how to complete health and safety checks to keep the environment safe.
- The childminder understands how to evaluate the provision and how to seek support and feedback from others, such as the local childminding coordinator and parents. She knows how to maintain her professional development to benefit the children.
- The childminder recognises the importance of working in partnerships with parents to share information and to get them involve in their children's learning.
- The childminder knows how to support children during the settling-in period, to help develop their emotional attachment. She understands how to support children's personal development and how to encourage positive behaviour.
- The childminder understands the importance of providing children with a wide range of indoor and outdoor resources and activities for them to explore and to support their learning and development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder how she intends to provide activities and experiences that promote children's learning.
- The inspector looked at the policies and documents the childminder intends to use when caring for children.
- The inspector discussed with the childminder her processes for self-evaluation and her improvement plan.
- The inspector viewed resources and toured the areas of the childminder's home that she intends to use for children.

The childminder registered in 1996. She lives in Ilford, within the London Borough of Redbridge. The childminder operates on weekdays throughout most of the year. There were no children on roll at the time of the inspection.
