Summary of key findings for parents

The provision does not meet requirements

- The childminder has not provided Ofsted with the necessary information so that all suitability checks can be completed on all household members. This is also a breach of the Childcare Register requirements.
- The childminder understands and knows how to respond to child protection concerns. She carries out checks on her premises to minimise risks and help keep children safe.
- The childminder knows how to assess children's learning, and provide a broad range of activities. She recognises the need to help children make good progress in their learning and to gain the skills needed for school.
- The childminder understands the need to help children to respect one another and to teach them how to behave well.
- The childminder understands the importance of working in partnership with parents to help provide continuity for children. She seeks parents' views on her service to help inform her self-evaluation and make improvements to her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
