# Summary of key findings for parents

## This provision is inadequate

- Leaders and managers do not have a secure understanding of their roles and responsibilities. Systems for evaluation are not robust enough to identify and address where there are breaches in legal requirements.
- Leaders and managers have not appointed a lead practitioner in the club who is trained and responsible for liaison with local statutory children's services. The manager has not checked the suitability of all persons working with or who have regular contact with children in the club. This means that children's welfare is not assured.
- The record of children's attendance is not maintained accurately. There are not enough persons with a valid first-aid qualification to ensure children receive prompt attention when needed.
- There are no arrangements in place to check that the manager and other adults working with children maintain good standards of practice. They have not appointed a deputy to manage the club in the manager's absence.
- Documentation with the name, home address and telephone number of anyone who has regular unsupervised contact with the children attending the club is not maintained well enough and is not available for inspection.

## It has the following strengths

■ The manager has worked hard to ensure that children's experiences in the club help them to enjoy and achieve. Activities help children to build on the skills they learn during the school day.

#### **Inspection activities**

- The inspector observed children's activities indoors and outdoors.
- The inspector held a meeting with the manager of the club. She looked at relevant documentation, such as the club's self-evaluation and evidence of the suitability of the manager, all adults working in the club and committee members.
- The inspector reviewed written information provided by parents and spoke to children and the adults in the setting at appropriate times during the inspection.
- The inspector evaluated activities with the manager of the club.

# **Inspection findings**

#### Effectiveness of the leadership and management is inadequate

The arrangements for safeguarding are not effective. Leaders and managers do not have a secure understanding of the safeguarding and welfare requirements. Not enough has been done to assure the safety and well-being of children. They have not appointed a designated lead practitioner who has attended appropriate training to provide pertinent support and guidance to staff on any specific safeguarding issues. Not all required documentation is in place. There is a variety of volunteer staff from the host school who support the employed manager. However, the manager does not have a record of their name, home address and telephone number. In addition, she has not kept a record of their suitability checks or made sure these are in place. Leaders and managers do not have suitable systems of supervision in place for the manager and all persons who work with or have regular contact with children. This means that they are not well supported in their roles and their performance is not monitored effectively. In addition, leaders have not ensured that a deputy manager is in place to cover in the absence of the manager. However, the manager and all persons working with or have regular contact with children are aware of the signs of abuse and the procedures to report any concerns. The manager ensures that physical risks in the setting are assessed and potential hazards are removed. The manager includes the views of parents and children in the evaluation process and welcomes their suggestions. However, evaluation has not been rigorous enough to identify where there are breaches in requirements.

#### Quality of teaching, learning and assessment is good

Children enjoy coming to the club. They have developed strong friendships with the children and the adults. Children are independent and confidently make choices in their play from a wide variety of activities. The manager is the key person and she works closely with parents and children to ensure that their individual needs are met. Children's voices are heard and they have a key role in planning how they spend their time in the club. Children's achievements and artwork are prominently displayed. This helps to promote a sense of belonging. The manager works closely with the staff in the host school, so that the activities provided allow children to build on the knowledge and skills they are learning during the day.

#### Personal development, behaviour and welfare are inadequate

Inadequate leadership and management mean that children's welfare is not assured. The manager does not keep an accurate record of attendance as required. It is not clear when individual children are present. The manager is the only person with a valid paediatric first-aid qualification. However, children use different areas of the school premises, including a large outdoor play space. This means that in an emergency, the club does not have an adequate number of qualified first aiders to respond to accidents immediately. Children explore their environment freely and demonstrate good levels of confidence. They learn about the benefits of daily exercise and fresh air. Children play cooperatively and behave well. They are respectful of others.

Our Lady's Out of School Care Club was registered in 1997. The club is open Monday to Friday during term time only. Sessions are from 8am until 8.45am and from 3.30pm until 6pm. There is one member of staff employed to work directly with the children. The staff member holds a level 3 qualification. The club has various volunteers from the host school working in the club.
