## Summary of key findings for parents

## This provision is good

- Children make good progress in relation to their starting points. The childminder uses accurate observations and assessments to monitor children's development and help them to achieve the next steps in their learning.
- The childminder maintains safe and secure play environments for children. She provides very good activities for them to learn about keeping safe. For example, children use picture cards to identify potential hazards around them and to learn how the safety measures keep them safe.
- Children develop very warm and trusting relationships with the childminder, with whom they share lots of affection and laughter to help support their well-being and happiness.
- The childminder obtains the views of parents to include in her self-evaluation and to help her make further improvements for those in her care. Parents provide very positive feedback regarding all aspects of her provision.

#### It is not yet outstanding because:

- The childminder misses some opportunities to support children to learn how to use different everyday tools to help extend their physical and creative skills further still.
- Occasionally, the childminder does not provide children with enough time to find the solution to a problem themselves, to help challenge their thinking still further.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- support children further in learning how to use a wider variety of everyday tools for themselves
- increase opportunities for children to solve simple problems for themselves to challenge their thinking further.

- The inspector observed activities and the quality of the childminder's interaction with the children.
- The inspector observed the management of children's care routines.
- The inspector looked at children's assessment records.
- The inspector sampled the childminder's documentation and discussed her knowledge of the requirements of the early years foundation stage.

# **Inspection findings**

#### Effectiveness of the leadership and management is good

Safeguarding is effective. The childminder has a secure understanding of her role and responsibility to support children's welfare. She undertakes regular professional development to extend her knowledge and skills. For example, she has attended several training courses which have helped her to keep up to date regarding safeguarding practices to protect children from harm and help them build positive lifestyles. The childminder reflects on the activities she provides to ensure they have a positive impact on children's enjoyment and progress and to make improvements. For example, she has introduced 'link books' to exchange information about children's interests, well-being and learning consistently with the other settings they attend.

### Quality of teaching, learning and assessment is good

The childminder uses good teaching skills to help her plan purposeful activities each week to meet children's individual learning needs. For example, she encourages children to make labels for the vegetable patch, to draw freely and to write their names to develop their early writing skills. She joins in children's play and provides support and challenge. She counts with younger children to introduce number language, and she challenges older children to find and name numerals and different shapes around them. The childminder involves parents well in children's learning. For example, she provides reports to show their children's progress, and book bags for them to develop children's interest in stories at home.

#### Personal development, behaviour and welfare are good

The childminder provides an exciting outdoor play area with many activities to contribute towards children's health and all-round development. She helps children to learn about the natural environment. For example, she organises gardening projects for children to plant seeds and learn about how vegetables grow. She provides natural resources and materials for children to explore and create freely with. The childminder helps children develop very positive attitudes and good behaviour. She is a calm and gentle role model who provides clear and consistent messages and lots of praise to help children take pride in their achievements.

#### **Outcomes for children are good**

Children develop key skills for their future learning and are well prepared to move on to school. For example, they are interested to investigate, learn and join in new activities, and they speak confidently in their play. Children develop very good social skills. They learn to treat others with kindness and consideration to help them make friends.
